CERTIFICATE OF WATER RIGHT

This Is to Certify, That HARVEY R. OTIS

of 1005 Durant Street, Modesto , State of California , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Snake River

a tributary of irrigation of 3.0 acres

for the purpose of

under Permit No. 27164 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from March 15, 1961

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.08 cubic fort per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW SEL, Section 14, T. 21 S., R. h6 E., W. N. Diversion point located 400 feet East and 50 feet South from the NW Corner of the SW SEL. Section 14.

SW SEA, Section 14.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-fortisth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4 acre feet per scre for each acre irrigated during the irrigation season of each year;


