Notice of a Right to a Hearing

Pursuant to ORS 537.409(8) you have the right to a hearing before the Oregon Water Resources Department to contest this order. The hearing, if requested, will be conducted according to ORS chapter 183 and the applicable administrative rules. If you want a hearing you must submit a request in writing to the Department within 60 days of the date of this order. To be timely a request must be received by the Department within the 60 day request period. If a request for a hearing is not received by the Department within the time allowed, you will have waived the right to a contested case hearing.

A request for a hearing must include:

- Your name, address, and telephone number;
- A statement that you are requesting a hearing;
- A detailed description of how the proposed final order is in error or deficient, and how to correct the alleged error or deficiency.

If you request a hearing, the Department will notify you of the time and place of the hearing. The Department will give you information on the procedures and other rights of parties relating to the conduct of the hearing before the hearing. You may be represented by counsel at the hearing.

If you do not request a hearing within 60 days of the date of this order or if you withdraw a request for a hearing, or request a hearing and then notify the Department that you will not appear or fail to appear at a scheduled hearing, the Director may issue a final order by default denying your application. If the Director issues a final order by default, the Department designates its file on this matter as the record.

Superseding Final Order

Application History

On February 13, 2007, DANIEL DAVIS submitted an application to the Department for a water use permit. Pursuant to ORS 537.409, the Department provided public notice of the application in the Department's weekly public notice. A 60 day comment period followed. The Department has not received adverse comments related to the possible approval of Application R-86768.

This Final Order supersedes the Final Order dated June 7, 2007, and is being issued because that Final Order was mailed erroneously to an incorrect address.

Water is available for the proposed use May 1 through July 31 and the month of October.

The Department has received comments from Oregon Department of Fish and Wildlife indicating that the proposed use poses a significant detrimental impact to an existing fishery resource, and that conditions can be applied to mitigate the detrimental impact. The condition recommended was capturing only water obtained from precipitation; otherwise only divert water when instream water rights and other senior water rights would not be injured.


The local watermaster, Mitch Lewis, determined that the proposed reservoir will have potential injury to existing water rights, and that conditions cannot be applied to mitigate the potential injury.

Therefore, the proposed use as described in Application R-86768 would either injure existing water rights, poses potential detrimental impacts to existing fishery resources, or both, pursuant to ORS 537.409(6).

Order

Application R-86768 therefore is denied.
