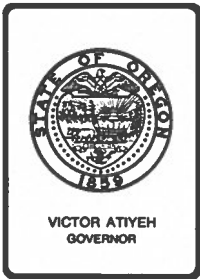

Your Application 65818 describing the proposed use of 0.67 cubic foot of water per second from the Mohawk River for the irrigation of 54.0 acres, together with the four prints of a map and legal description of the property, has been reviewed.

We also received your request for waiver of the normal waiting period.

Item 6 on the application makes reference to holding bonds. As mentioned when the application was filed, the permit approving the application will only provide for the use of water for irrigation purposes. The permit would not provide for the storage of water or appropriation of water from Mohawk River for maintaining the ponds for aesthetic purposes. If it is intended to appropriate water for storage or for aesthetic purposes, the necessary applications and supporting data should be submitted.

The application as prepared for irrigation purposes is in satisfactory form and your request for waiver of the 30 day waiting period will now be considered.

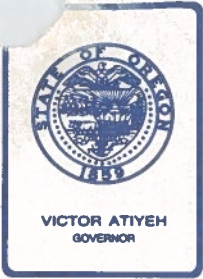
