We are enclosing a drawing of a proposed location for a country club. We are in the process of organizing such a club here in Springfield.

The red shaded area on the enclosed drawing is that property on which we are contemplating our golf course. Before we can proceed, however, we wish to know if we can receive permission from your office to pump the water we need for irrigation of the greens and fairways.


The property contains 96.71 acres, all located in Section 3, Township 17S, Range 2W in Lane County.

We propose pumping the water from the Mohawk river at three points where it passes through the property. Approximately 750,000 gallons per day will be needed during the summer months.

We are extremely anxious to hear from you, because our future plans are contingent upon this water right.

Gentlemen:

This will acknowledge your application for a permit to appropriate water from the Mohawk River for the irrigation of 90 acres, the accompanying map, legal description, and payment of fees in the amount of \$36.50, for which our Receipt No. 19111 is enclosed.

The application has been examined, given File No. 32520, and the following defects are noted:

Map: The tie to each end of the travel of the portable pumps should be shown on the map. The number of acres to be irrigated within each 1/16th of a section should be indicated on the map.

Application Item 4: The travel of the pumps should be further located as being within specific 1/16ths of a section.

Item 8: The area to be irrigated should be listed as being within specific 1/16ths of a section with the number of acres to be irrigated within each 1/16th listed separately.

Your application and map are returned herewith for completion with the application being endorsed so that in order to retain its date of priority it must be returned to this office on or before October 8, 1958.






Gentlemen:

This will acknowledge receipt of your notice to the effect that complete application of water has been made under Permit No. 25691.

Pursuant to your report and in line with the general practice of this office a survey will be made at a later date. After this survey, proof may be made and certificate issued covering the actual use of water as found by the engineer. In case of irrigation, any lands described in the permit that have not been irrigated will be automatically eliminated from the water right.

In the meantime, the permit which you hold will be valid evidence of the water right in question so long as you continue to use the water.

Dear Sir:

On June 13, 1962, we mailed you a copy of a draft of the certificate in connection with the incomplete water right represented by your permit number 25691 granting a right to the use of 1.13 c.f.s. from the waters of Mohawk River for irrigation of 90.55 acres, together with the instructions that the statement under "Final Proof" be signed at the bottom of the page and the copy be returned to this office accompanied by the certificate recording fee in the amount of \$1.

To date this form has not been received nor has any correspondence regarding reasons for not returning it been received. This is to notify you that unless we receive the signed draft form and the certificate recording fee, or a request for additional time within thirty days from the date of this letter, we will be required to take steps toward the cancellation of this permit.
