RE: City of Prineville - Application for Limited Water Use License

Dear Mary:

The enclosed application for a Limited Water Use License, and supporting documentation, is submitted on behalf of City of Prineville (City). Also enclosed is the \$280 application fee. In summary, the City is proposing to appropriate groundwater at a rate of not to exceed 1,200 gallons per minute for municipal use within the City's service area. The City anticipates that the annual appropriation will not exceed 756 acre-feet.

We understand that since this limited water use license application requests to appropriate groundwater within the Deschutes Ground Water Study Area, the Oregon Water Resources Department's practice, under OAR Chapter 690, Division 33, is to require "mitigation" for potential impacts to surface water. To address "mitigation" for the proposed limited license, the City will limit the combined annual volume of water appropriated under the City's Permits G-17577, G-18155 AND this proposed limited license, to no more than the maximum annual volume authorized under Permits G-17577 and G-18155, which is currently 1,509.75 acre-feet. Please note that this volume of 1,509.75 acre-feet will increase if the City assigns additional mitigation credits to Permits G-17577 and G-18155.

Under Permits G-17577 and G-18155, the City currently provides 603.9 permanent mitigation credits in the Crooked River Zone of Impact. With this number of current mitigation credits (at an estimated year-round consumptive use coefficient of 40 percent) the City is authorized to appropriate up to 1,509.75 acre-feet annually ($603.9/0.4 = 1,509.75$). Tables 1 and 2 document the permanent mitigation provided for Permits G-17577 and G-18155 to date.

PLEASE READ CAREFULLY

NOTE: A completed water availability statement from the local watermaster, Land Use Information Form completed by the local Planning Department, fees and site map meeting the requirements of OAR 690-340-030 must accompany this request. The fee for this request is **\$280** for the first point of diversion plus **\$30** for each additional point of diversion. Please review the Department's fee schedule to view fees required to request a limited license for Aquifer Storage and Recovery testing purposes or for Artificial Groundwater Recharge testing purposes.

Failure to provide any of the required information will result in return of your application. The license, if granted, will not be issued or replaced by a new license for a period of more than five consecutive years. The license, if granted, will be subordinate to all other authorized uses that rely upon the same source, or water affected by the source, and may be revoked at any time it is determined the use causes injury to any other water right or minimum perennial streamflow.

If water source is well, well logs or adequate information for the Department to determine aquifer, well depth, well seal and open interval, etc. are required. The licensee shall indicate the intended aquifer. If for multiple wells, each map location shall be clearly tied to a well log.

If a limited license is approved, the licensee shall give notice to the Department (Watermaster) at least 15 days in advance of using the water under the Limited License and shall maintain a record of use. The record of use shall include, but need not be limited to, an estimate of the amount of water used, the period of use and the categories of beneficial use to which the water is applied. During the period of the Limited License, the record of use shall be available for review by the Department upon request.

REMARKS:

The applicant proposes that the combined annual volume of water appropriated under the City of Prineville's Permits G-17577, G-18155, and this proposed limited license will be limited to no more than the maximum annual volume authorized under permits G-17577 and G-18155. This volume is currently 1,509.75 acre-feet, but will increase if the City assigns additional mitigation credits to permit G-17577 or G-18155.
