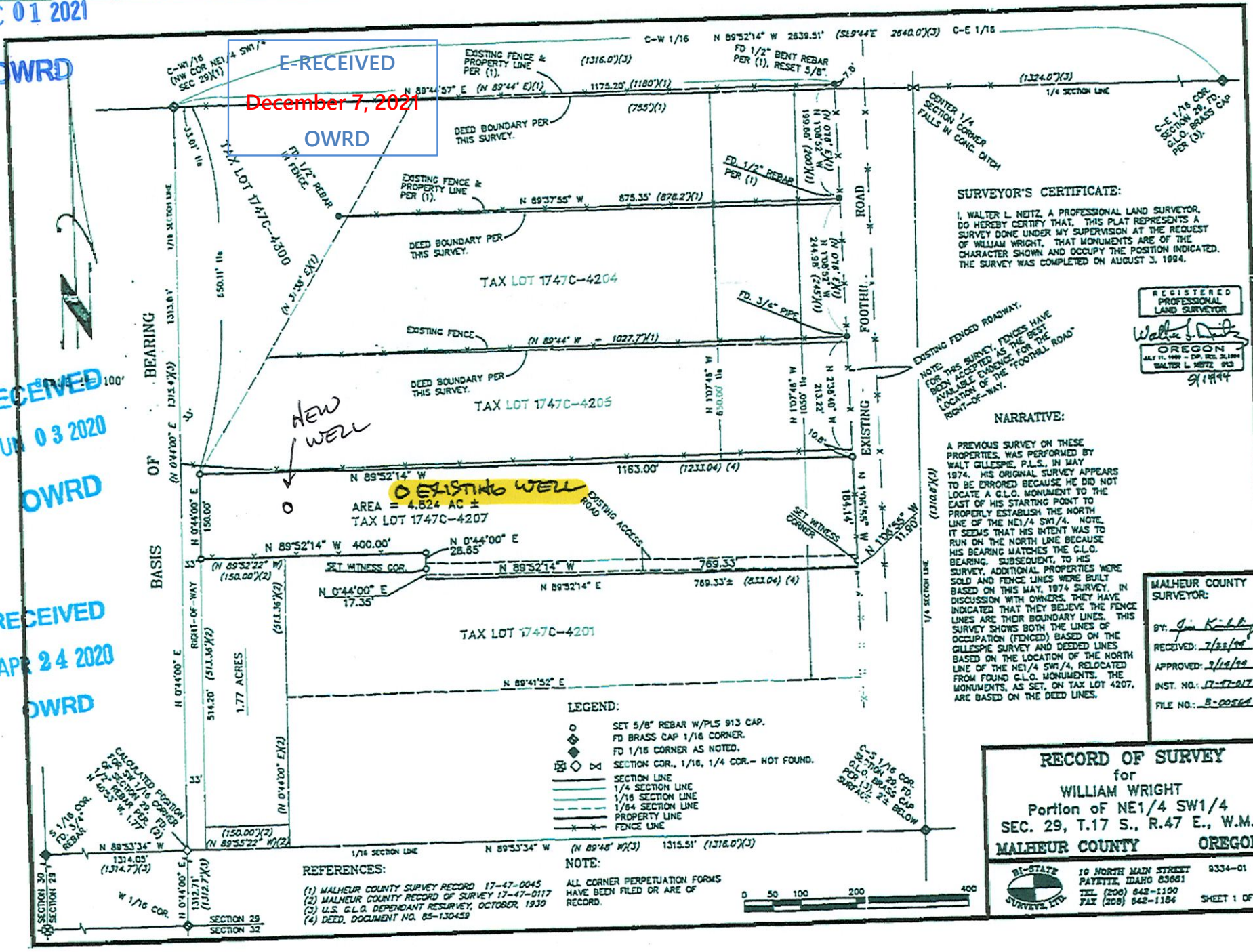

NARRATIVE:

A PREVIOUS SURVEY ON THESE PROPERTIES WAS PERFORMED BY WALT GILLESPIE, P.L.S. IN MAY 1974. HIS ORIGINAL SURVEY APPEARS TO BE ERRORED BECAUSE HE DID NOT LOCATE A G.L.C. MONUMENT TO THE EAST OF HIS STARTING POINT TO PROPERLY ESTABLISH THE NORTH LINE OF THE NE 1/4 SW 1/4. NOTE IT SEEMS THAT HIS INTENT WAS TO RUN ON THE NORTH LINE BECAUSE HIS BEARING MATCHES THE G.L.C. BEARING. SUBSEQUENT TO HIS SURVEY, ADDITIONAL PROPERTIES WERE SOLD AND FENCE LINES WERE BUILT BASED ON THIS MAY, 1974 SURVEY. IN DISCUSSION WITH OWNERS, THEY HAVE INDICATED THAT THEY BELIEVE THE FENCE LINES ARE THEIR BOUNDARY LINES. THIS SURVEY SHOWS BOTH THE LINES OF OCCUPATION (FENCED) BASED ON THE GILLESPIE SURVEY AND DEEDED LINES BASED ON THE LOCATION OF THE NORTH LINE OF THE NE 1/4 SW 1/4, RELOCATED FROM FOUND G.L.C. MONUMENTS. THE MONUMENTS, AS SET, ON TAX LOT 4207, ARE BASED ON THE DEED LINES.

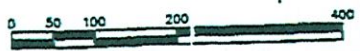

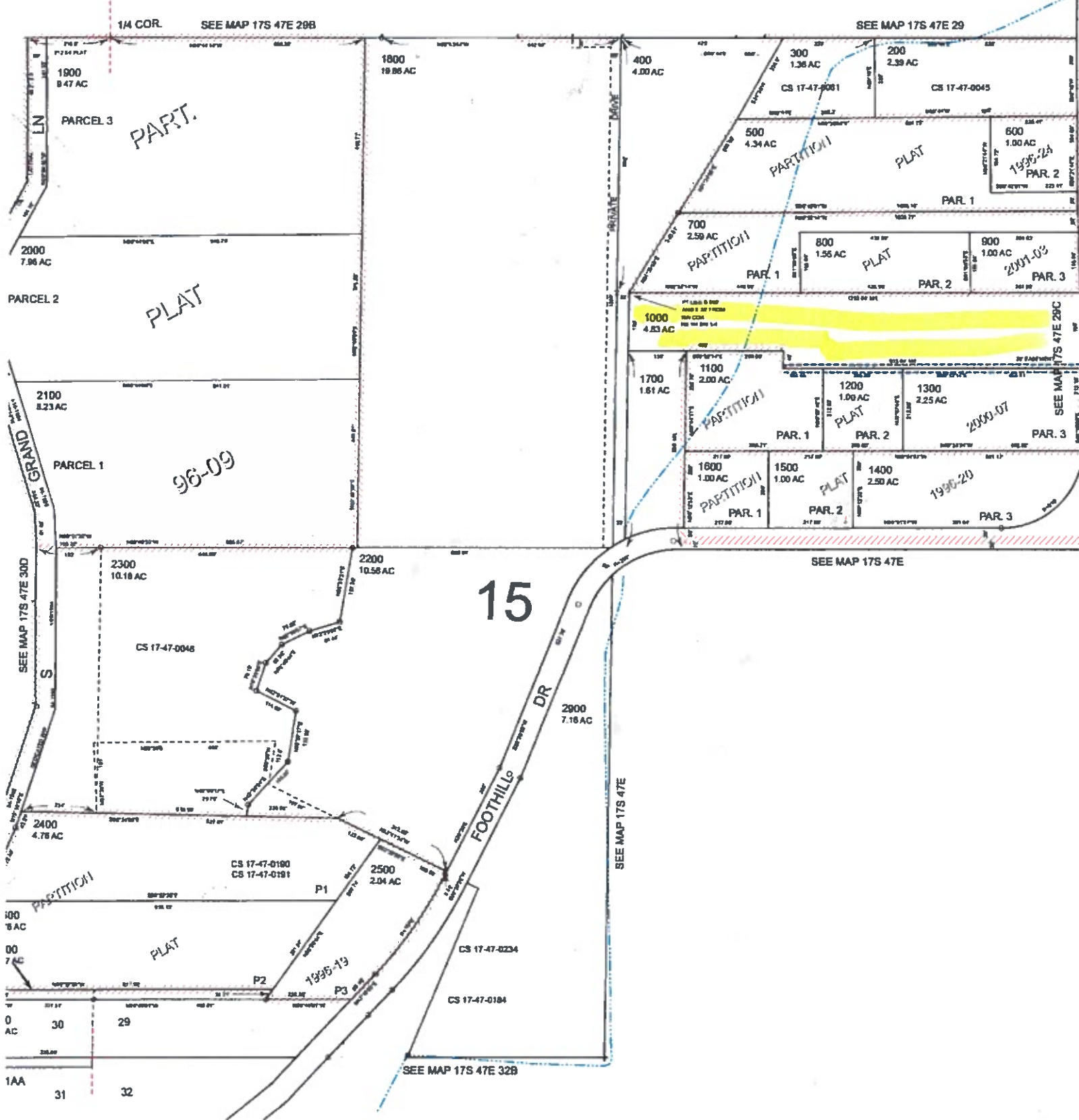
