

We have received two assignment requests for permit 44298, in the names of Steven E. and Robin Lou Miller along with a check in the amount of \$10. The statements of use were also received.

Unless you can get Steven and Robin to sign the same form, we will have to have an additional \$10 to record the second assignment. I have enclosed both forms for your action, either by returning the two forms with \$10 or one form with both signatures.

The permit granted the right to the use of water from Salmon Creek for the irrigation of 6.2 acres, stock and domestic use for one family. We received a letter form Mr. Miller in June 1983 advising us that he was not able to complete the project. In effect, he said domestic use from the creek had been abandoned in favor of a well and he was not able to full use of water for irrigation and wanted an extension of time. There was no mention of stock use. Although the application was sent to him, we did not receive money nor the application requesting more time to complete the project.

Under the terms of the permit, complete use of water was to have been made by October 1, 1981. Based upon information in the notices you sent, only 2.2 acres have been watered and the permit will be restricted accordingly, but will you clarify the domestic use?

Further action will be withheld on this file for a reasonable length of time pending your reply.

According to the terms of your Permit 44298 which was for 0.09 cubbe foot per second of water from Salmon Creek for irrigation, stock & domestic uses for one family in Coos County.

Complete application of water means the application of water to a beneficial use under the permit to the full extent intended. In the case of irrigation, it means beneficial irrigation of all the lands the permittee intends to cover under the terms of the permit. If the water has been used, you should promptly submit notice describing the extent of completion as set forth in the letter accompanying your permit and also in our postal card of October 12, 1982

ORS 537.260 provides that: "Whenever the time within which any appropriation under a permit should have been perfected has expired and the owner of the permit fails or refuses within three months thereafter to submit to the Water Resources Director proof of completion of the appropriation as required by ORS 537.230 and 537.250, the Water Resources Director may, after 60 days notice by registered mail, order the cancellation of the permit..."

In accordance with the provisions of ORS 537.260, you are hereby notified that unless proof of beneficial use is received within 60 days from the date of this letter, the permit(s) may be canceled without further notice.

If for any reason, you are no longer interested in the project described by the permit, we would appreciate it if you would so advise. If the property involved has changed hands and any part of the project has been completed, you should immediately assign the permit to the new owner and advise us of his name and address. An assignment form will be furnished upon request.

Dear Mr. and Mrs. Miller:

Thank you for the letter regarding the status of the project described in your Permit Number 44298. We also have your notice of Beginning of Construction.

We will use your notice as satisfying the requirement for making a substantial beginning of construction of the project. I have enclosed an application form for your use to complete and submit with a fee of \$20 so that you can request an extension of time limits of the permit. Please note, generally only a one year extension can be granted and this is based on whether or not the water user has shown diligence toward carrying out the project. Based on the information you have provided, it is questionable that we could grant an extension. If your request is denied, the fees will not be refunded, so go into detail regarding the irrigation equipment on hand and water system for stock use as well as listing the number of acres irrigated.

A permit is not\_required to use water from a well for domestic supplies. Although domestic use has not been defined by Oregon law, it is generally accepted to mean household use of water only.

Thank you for your letter regarding your Permit Number 44298.

Your permit was issued with the understanding that we be kept-up-to-date regarding the progress of the project. Under the terms of the permit, a substantial beginning of construction of the water system for domestic, stock, and irrigation was to have been made by August 8, 1980. The water system was to have been completed, to include plumbing of the house for domestic use, by October 1, 1981 and water was to have been used to the fullest extent intended on or before October 1, 1982. To date, we have not been advised as to whether or not these requirements were met. Forms for reporting are enclosed.

In the event you did not make a substantial beginning of construction of the water system by August 8, 1980, the permit is not valid and will have to be canceled.

Your application for a permit to appropriate 0.09 cubic foot per second of water from Salmon Creek for domestic use for one family, stock watering and irrigation of 6.4 acres has been filed as No. 58712.
