CERTIFICATE OF WATER RIGHT

This Is to Certify, That DORALD W. STRYKER

of Langlois , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of an unpassed stream

a tributary of Hev Lake

for the purpose of

domestic use for one family under Permit No. 17751 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from May 16, 1947

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed ...0.01 cubic feet per second.

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the (SE\ NE\) Lot 8. Section 26. Township 30 South, Range 15 West, W. N..

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to _ _ _ _ of one cubic foot per second per acre,
