Period of Use remains the same as the transferred irrigation right and is limited to March 1 through October 31. In compliance. The well has never been activated prior to March 1 and has never been used after midnight of October 31st.

Pumping rate is limited to 0.33 cfs (148.11 gpm). In Compliance. The well is currently pumped at a rate of approximately 60 gpm.

Water use is further limited to 208.25 acre-feet (67,858,262 gallons) per year. In Compliance. Volume varies from year to year, but has not exceeded the allowed volume.

An initial meter reading shall be submitted to the Department. Unsure what was submitted in the past. Meter was installed and began at 0 in February of 2011. First use was in 2011 with 755,240 gallons pumped. Chart of Usage by Year, prepared from the Perrydale Water Association spreadsheet of meter reading, is attached.

An initial meter reading shall be submitted every year on March 1 or before water use begins. Chart of Usage by Year is attached. This unusual condition has been somewhat difficult to comply with as the WRD has no format in its report of use program to accommodate it.

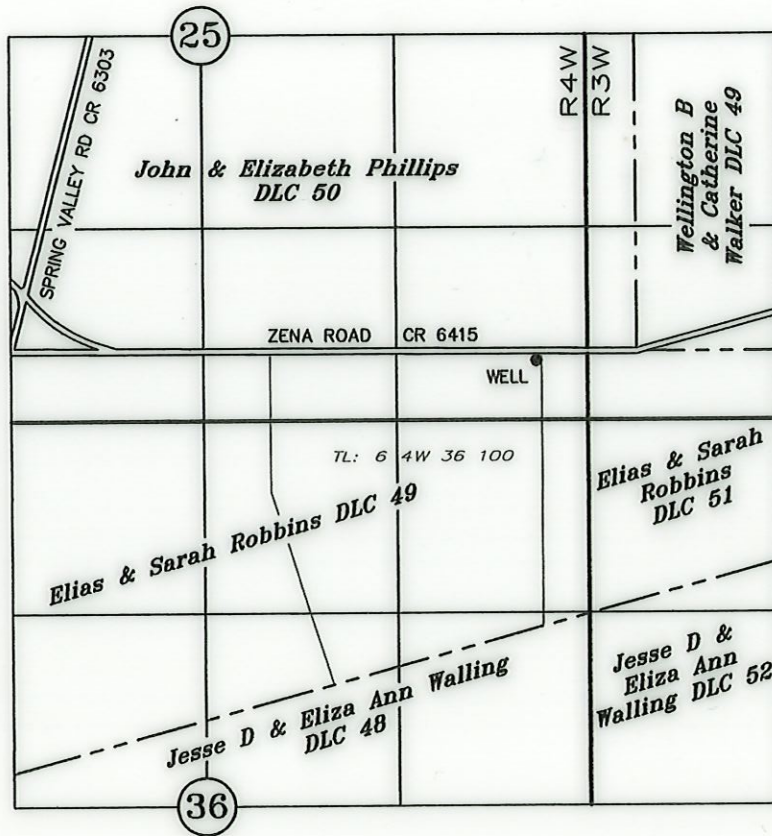
