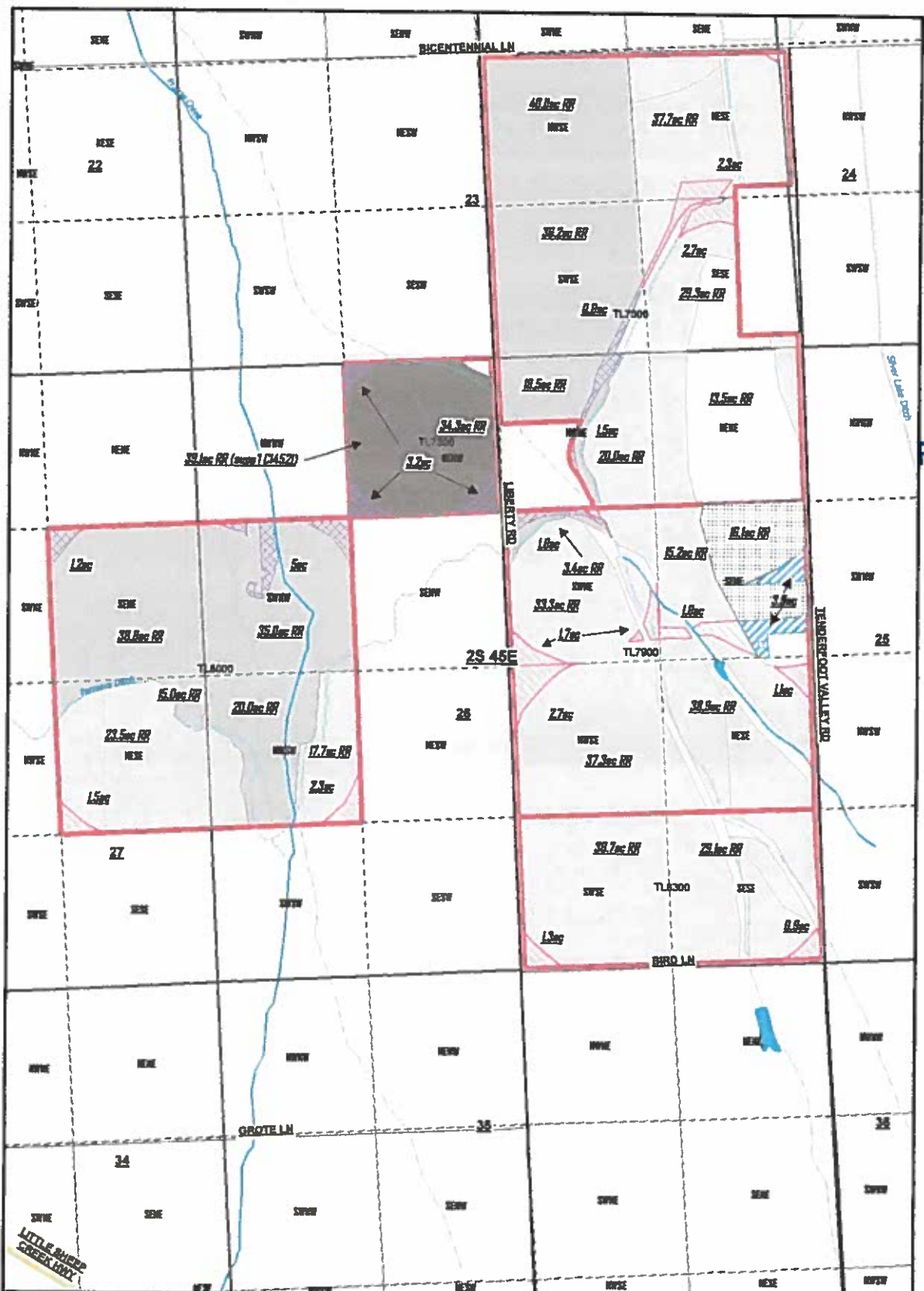

QUITCLAIM DEED

Associated Ditch Companies, Inc., an Oregon nonprofit corporation, Grantor, is the holder of certain water storage and beneficial use rights described in State of Oregon Certificate of Water Right No. 2949, No. 9310, No. 9311, No. 86543, and No. 87896 ("Water Rights").

Wallowa Lake Irrigation District ("WLID"), an irrigation district formed under the provisions of ORS Chapter 545, was formed at the direction of and through the facilitation of Grantor for purposes of raising capital to rehabilitate the Wallowa Lake dam. It is the intent and desire of Grantor to transfer all of its interest in the Water Rights to WLID for said purposes.

In consideration of the above, Grantor releases and quitclaims to WALLOWA LAKE IRRIGATION DISTRICT, Grantee, any right, title, and interest which Grantor may have in the Water Rights as set forth in State of Oregon Certificate of Water Right No. 2949, No. 9310, No. 9311, No. 86543, and No. 87896.

The true and actual consideration for this conveyance is value other than money.

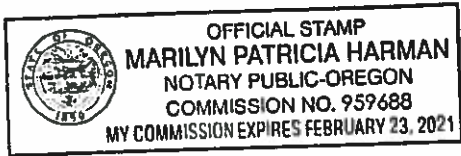
