Pursuant to ORS 536.075 and OAR 137-003-0675, you may petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

Application History

Permit G-16471 was issued by the Department on April 23, 2009. The permit specified completion of construction by April 23, 2014 and complete application of water to beneficial use by April 23, 2014. On January 29, 2021, Sam McDaniel submitted an Application for Extension of Time for Permit G-16471. In accordance with OAR 690-315-0050(2), on April 6, 2021, the Department issued a Proposed Final Order proposing to extend the time to complete construction to October 1, 2022, and the time to fully apply water to beneficial use to October 1, 2022. The protest period closed May 21, 2021, in accordance with OAR 690-315-0060(1). No protest was filed.

FINDINGS OF FACT

ORDER

The extension of time for Application G-16980, Permit G-16471, therefore, is approved. The deadline for completing construction is extended from April 23, 2014, to October 1, 2022. The deadline for applying water to full beneficial use within the terms and conditions of the permit is extended from April 23, 2014, to October 1, 2022.
