

The Department has been reviewing the Claim of Beneficial Use (claim) report and map, received on March 5, 1997. The Department is prepared to issue a proposed certificate for this permit; however the Department has identified an issue that must be resolved before the issuance of a certificate.

The Department has identified Nichols as the new landowner for Tax Lots 100 and 201, for properties located in Section 29. The Department has identified Lamb as the new landowner for Tax Lots 3400, 3501, and 3700. The Department currently has and approved a pump test for Well No. 1 (Lamb). In order to issue the DRAFT Certificate (attached), the Department needs a pump test for Well No. 2 (Nichols).

The Pump Test requirement for the permit has not yet been satisfied. Oregon Administrative Rule 690-217-0020(1) requires that ground water permit holders with a priority date on or after December 20, 1988 submit the results of a pump test for each well listed in your claim of beneficial use before a water right certificate can be issued. These rules also allow the well owner to request one of two types of exemptions related to the testing of the well(s). The first type of exemption request is for an "Unreasonable Burden." This exemption can be requested if testing the well(s) would place an unreasonable burden on the well owner (OAR 690-217-0015(3) and (4)). Examples could include a) an economic hardship or b) the test would cause an interruption of services to customers or possible other necessary uses from the well (domestic, livestock, ect.). The second exemption request allows an owner with multiple wells to request that a qualifying, previously approved pump test on one of their wells be used to satisfy the requirement for additional wells under their ownership (OAR 690-217-0020(3)). No fee is required to request either type of exemption. Exemptions must be requested in writing using one of the two exemption forms before being considered. A one page description of the Pump Test Program along with the necessary forms to request either type of exemption or perform the test is attached. Oregon Administrative Rule 690-217-0020(1) requires that ground water permit holders with a priority date after December 20, 1988, submit the results of a pump test before the Water Resources Department can issue a water right certificate. A copy of your permit is enclosed. The purpose of this letter is to remind you of the pump test requirement.

Pump tests are intended to provide aquifer and well information for ground water resource characterization and to help solve well problems. There is no penalty for not submitting a pump test.

If there is a reason why a pump test cannot be performed on a well, the owner may request from the Director an exemption from the pump test requirement. Requests shall be in writing and include the reason why a pump test cannot be performed. Exemptions, or conditioned exemptions, shall be granted if the reasons are found to be valid and eliminating the problem would place an unreasonable burden on the well owner. Exemptions shall be granted for public water supply wells if pump testing will cause interruption of service to customers.

Pump tests shall not be required of wells with diameters greater than 36 inches and depths less than 30 feet. Pump tests shall not be required of collector-type wells or infiltration galleries. If your well meets one of these two requirements please let us know.

If you are interested in conducting the pump test yourself, you should first review the requirements at <u>http://arcweb.sos.state.or.us/rules/OARS\_600/OAR\_690/690\_217.html</u> or ask that a copy of the rules be sent to you.

- A. Before water use may begin under this permit, the permittee shall install a meter or other suitable measuring device as approved by the Director. The permittee shall maintain the meter or measuring device in good working order.
- B. The permittee shall allow the watermaster access to the meter or measuring device; provided however, where the meter or measuring device is located within a private structure, the watermaster shall request access upon reasonable notice.
- C. The Director may require the permittee to keep and maintain a record of the amount (volume) of water used and may require the permittee to report water use on a periodic schedule as established by the Director. Failure to comply with any of the provisions of this permit may result in action including, but not limited to, restrictions on the use, civil penalties, or cancellation of the permit.

I talked to Tom Davis about the need for a measuring device or another method of measuring his use. If he uses his pump GPM and figures the usage from his power bills for the season and they are separate for each well, they could satisfy the reporting requirement when needed. I assisted Tom in figuring his usage for 1995 and 1996. Well #1 used 1.71 acf in 1995, 2.25 acf in 1996. Well #2 used 1.23 acf in 1995 and 2.36 acf in 1996.

The in line meeters are expensive and do not last depending on the size and pressure in the lines. The wells in this area are very stable and recharge even in the drought years. At some future date a positive meter may be needed.

**PUBLIC INTEREST REVIEW** 

The proposed water use described in Application #G-12664 has been evaluated according to the public interest standards set out in ORS 537.170 and OAR 690-11-195.

The Report of Technical Review for Application #G-12664 proposes allocation of <u>3.23 CFS</u> from <u>TWO WELLS</u> within the <u>WARNER LAKES</u> Basin for the purpose(s) of <u>IRRIGATION OF 258.4 ACRES</u>. The Technical Review Report limits the proposed use to <u>IRRIGATION</u> <u>DURING THE PERIOD MARCH 1 THROUGH OCTOBER 31</u>.

The proposed use described in Application #G-12664 is not within a category required to be submitted to the Commission.

The Director of the Water Resources Department has evaluated the Application for the proposed water use and made the following public interest determination.

TECHNICAL REVIEW

Water use Application #G-12664 received a Satisfactory Report of Technical Review.

The Technical Review revealed that the proposed water use:

a) - is not prohibited by statute or scenic waterway criteria;

- b)-is a classified use under the applicable basin program or an application for the use has been filed under ORS 536.295 and OAR 690 Division 82;
- c)-is consistent with conditions previously imposed by the Commission on appropriations from the same source;
- d)-will not conflict with (an) existing water right(s);
- e)-is supported by an available source of water.

#### PUBLIC INTEREST REVIEW CHECKLIST

The Director of the Water Resources Department has evaluated the proposed water use, as described in Application #G-12664, in light of current and planned uses and reasonably anticipated future demands for water from the water source as established in the record.

The evaluation has recognized known beneficial uses of water, including but not limited to the categories described in OAR 690-11-195(3)(a)-(d).

The Director has reviewed the elements of the proposed water use and has based the public interest determination on evidence in the record which included the following:

I. Existing claims to water from the same source.

✓ There are no conflicts with existing claims to water from the same source as is documented in the Report of Technical Review.

- II. Land use matters.
- The local government where the proposed water use is located has acknowledged receipt of the Land Use Information Form and has filed no objections to the proposed appropriation.
- ✓ Public notice of the proposed water use was sent to all local governments which have requested such notice and none of those local governments have filed objections to the proposed water use.
- ✓ There is nothing in the record to indicate the proposed water use is incompatible with Statewide Planning Goals or local comprehensive plans.
- If local government approval has not been granted, there is nothing in the record to indicate conditions cannot be placed on the proposed water use to require local land use approval prior to initiation of the use.
- An applicant for municipal water use has submitted information showing the proposed water use is compatible with comprehensive plan policies concerning urban services, urban growth boundaries, and Public Facilities Plans.

#### III. Identified environmental concerns.

- ✓ The proposed water use does not appropriate water from any water body listed to receive Total Maximum Daily Loads and therefore, the water body has not been defined as water quality limited according to Section 303(d)(1) of the federal Clean Water Act according to the information supplied by the Oregon Department of Environmental Quality.
- IV. The character and extent of other natural resources which are present in the water source basin.
- ✓ The Oregon Department of Fish and Wildlife (ODFW) has been notified of the proposed water use and has made no objections regarding fish and other aquatic and wildlife species and populations.
- ✓ There are no listed threatened or endangered species in the water source according to the information supplied by the Oregon Department of Fish and Wildlife.
- V. Riparian characteristics.
- ✓ There is nothing in the record to indicate the proposed use is likely to be detrimental to the riparian characteristics of the water source. This riparian review is not applicable to groundwater sources.
- VI. Recreational use and potential of the water source and its basin area.
- There is nothing in the record to indicate a conflict with known or reasonably anticipated recreational use.
- VII. Agricultural potential of the area.
- ✓ There is nothing in the record to indicate the proposed water use will conflict with known or reasonably anticipated agricultural practices.
- VIII. Designated historic, cultural, or natural resource protection areas.
- There is nothing in the record to indicate any conflict with any known or reasonably anticipated historic, cultural, or natural resource designations.
- IX. Identified health or safety requirements.
- There nothing in the record to indicate any identified health and safety requirements.

#### PUBLIC INTEREST REVIEW FINDINGS AND CONCLUSIONS

This public interest determination has considered the following standards as set out in ORS 537.170(5):

- a) The conservation of the highest use of the water for all purposes, including irrigation, domestic use, municipal water supply, power development, public recreation, protection of commercial and game fishing and wildlife, fire protection, mining, industrial purposes, navigation, scenic attraction or any other beneficial use to which the water may be applied for which it may have a special value to the public.
- b) The maximum economic development of the waters involved.
- c) The control of the waters of this state for all beneficial purposes, including drainage, sanitation and flood control.
- d) The amount of waters available for appropriation for beneficial use.

The Director of the Water Resources Department, pursuant to OAR 690-11-185(4), has considered the facts set forth in the Application and its supporting data, the Director's Report of Technical Review and any objections which met the requirements of OAR 690-11-170(1).

We are required by the state of Oregon's administrative rules (in OAR 690-11-160) to conduct this official technical review of each application submitted to the Oregon Water Resources Department for a water use permit. This process was designed to insure that your application receives a fair evaluation and to secure protection of existing water rights and of the public at large.

AS THE RESULT OF OUR TECHNICAL EVALUATION OF YOUR APPLICATION, WE HAVE DETERMINED THAT YOUR APPLICATION SATISFIES THE REQUIREMENTS OF THE TECHNICAL REVIEW.

The Department will now move your application to the next phase of processing. This phase includes a public interest review of your proposed water use. No final action may be taken on your application until the public interest review is completed.

All evidence and objections must be received by our Salem office no later than 5:00 p.m. on or before September 24, 1993 or the Department may presume there is no opposition to any of the analyses set out in the technical review report. If objections and evidence are submitted on or before the above time and date, the Director of the Water Resources Department will evaluate each issue raised in the objections and either accept or deny them. If any of the objections are denied, the objector will be allowed thirty days to submit a protest to the denial. The protest must meet the standards set forth in OAR 690-02-030 through 080.

#### GROUNDWATER AVAILABILITY

This is an application for use of groundwater. The Groundwater/Hydrology Section report indicates that:

Pursuant to OAR 690-09-040, the proposed groundwater withdrawal will not have the potential to cause substantial interference with surface water.

In addition, the Groundwater/Hydrology Section has reported the water **is** likely to be available to supply the proposed use.

#### CONFLICTS WITH OTHER WATER RIGHTS:

There **are no** existing rights from this point of diversion.

There **are no** existing water rights appurtenant to the lands described in the application. See proposed permit conditions.

#### **REPORT CONCLUSIONS:**

This Report of Technical Review sets out the Director's technical analysis of the application. In addition to this technical analysis, the Director will evaluate this application to determine whether the proposed water use might impair or be detrimental to the public interest under the standards set out in ORS 537.170(5) and OAR 690-11-195. Matters relating to public interest in the proposed water use which are raised in objections will be evaluated following the 60-day objection period.

#### PROPOSED PERMIT CONDITIONS

### Application: G-12664

The following conditions will apply to water use under the permit, and will in the permit, if issued.

- 1. Period of allowed use: MARCH 1 THROUGH OCTOBER 31
- 2. Rate: 3.23 CFS BEING 1.675 CFS FROM WELL 1 AND 1.555 CFS FROM WELL 2
- 3. The amount of water used for irrigation under this right, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 3 acre-feet for each acre irrigated during the irrigation season of each year.
- 4. Water use development requirements:
  - A) Begin construction by (one year from issuance of permit).
  - B) Complete construction by October 1, 1995.
  - C) Completely apply the water to beneficial use by October 1, 1996.
- 5. The well shall be constructed in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon. The works shall be equipped with a usable access port, and may also include an air line and pressure gauge adequate to determine water level elevation in the well at all times.
- 6. Measurement, recording and reporting conditions:
  - A. Before water use may begin under this permit, the permittee shall install a meter or other suitable measuring device as approved by the Director. The permittee shall maintain the meter or measuring device in good working order, shall keep a complete record of the amount of water used each month and shall submit a report which includes the recorded water use measurements to the Department annually or more frequently as may be required by the Director. Further, the Director may require the permittee to report general water use information, including the place and nature of use of water under the permit.
  - B. The permittee shall allow the watermaster access to the meter or measuring device; provided

however, where the meter or measuring device is located within a private structure, the watermaster shall request access upon reasonable notice.

- 7. Prior to receiving a certificate of water right, the permit holder shall submit the results of a pump test meeting the department's standards, to the Water Resources Department. The Director may require water level or pump test results every ten years thereafter.
- This right is limited to any deficiency in the available supply of any prior right existing for the same land.
- 9. Failure to comply with any of the provisions of the permit may result in action including, but not limited to, restrictions on the use, penalties, or cancellation of the permit.
- 10. The permit is for the beneficial use of water without waste. The water user is advised that new regulations may require the use of best practical technologies or conservation practices to achieve this end.
- 11. The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.
- 12. The use of water shall be limited when it interferes with any prior surface or ground water rights.




