



This letter is in regards to fish screening and fish passage device requirements set forth in Oregon Water Resources Department Permits S-54861 and S-54862. These permits are associated with adjoining properties owned and managed by Dr. Carl Stevens, located at 24849 NE Butteville Rd, Aurora, OR. Both water rights are sourced from the Willamette Basin Project Reservoirs, and both are limited to a maximum volume of 15 acre feet.

The point of diversion for each respective permit is an end-of-pipe diversion, so bypass devices are not necessary for fish passage. In regards to fish screening requirements, the two points of diversion associated with these permits will be equipped with Sure-Flo SCS2 fish screens and each will be operated in conjunction with a 1.25 HP pump. These screens effectively screen up to 44 gpm, which will exceed National Marine Fisheries Service fish screen criteria for the allotted water rights.

Both fish screen and passage requirements are met for these diversions. If you have any questions regarding this information, please do not hesitate to contact me at 541-296-8026.
