Intent to Partially Perfect Permit G-16148 and Request for Reimbursement Authority Processing

Dear Ms. Kavanagh:

In accordance with Oregon Administrative Rule (OAR) 690-320-0040(4), this letter provides formal notification that the Springfield Utility Board (SUB) hereby intends to partially perfect 70 percent of the municipal water right developed under Permit G-16148 and transmits the related Claim of Beneficial Use (CBU). The processing fee of \$230 is enclosed.

This letter also provides additional information required under OAR 690-320-0040(4) to support the requested partial perfection. We have enclosed a Reimbursement Authority (RA) application for the expedited processing of the CBU and a related \$125 check payable to the Oregon Water Resources Department.

Background

Permit G-16148 authorizes a total pumping rate of 4.91 cubic feet per second (cfs) of water from four wells in the Cedar Creek Basin. The priority date of the right is December 11, 2000. The current Points of Appropriation (POA) are three wells (Wells 5, 6 and 7) constructed as part of SUB's Thurston Wellfield. The fourth well, designated Well 10, has not been constructed to date.

The partial development of this 3.43 cfs of the 4.91 cfs right will reduce the remaining unperfected amount of water to 1.48 cfs.

Quantity of Water Diverted in Previous Three Years

The following provides the quantity of water in acre-feet pumped from Wells 5, 6 and 7 between January 2018 and May 2021 based on the Water Use Report page of the WRD's website and SUB's records.

Plan to Develop Successive Increments of the Right

The completion date for development of the water use authorized by the permit is January 2, 2027. SUB will use and develop the remaining 1.48 cfs of water authorized by Permit G-16148 in response to present and future water demand. A summary of the projected water demands and a proposed plan for meeting the forecasted increased water demand are summarized in the SUB and Rainbow Water District joint Water Management and Conservation Plan. The Department approved the Plan on June 28, 2018.

Map Showing Where Water Will Be Put to Use

The permit map is currently on file with the Department. SUB will develop and use the remaining portion of Permit G-16148 to meet water demand in accordance with the terms and conditions of the permit.
