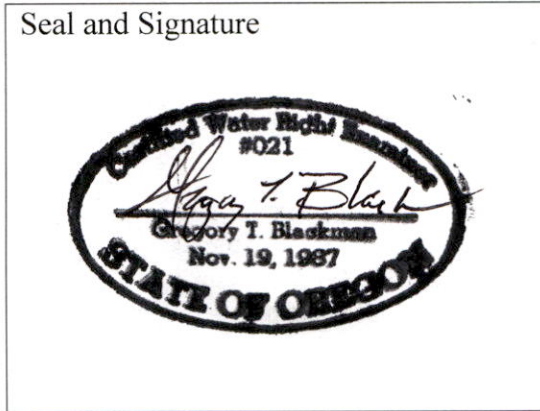

I used a Leica GPS GS 14 receiver to tie the existing point of diversion and record the Latitude and Longitude of the pump site. The section corner for the NE corner of Section 10, T2S R39E, is not monumented and was achieved by visually intersecting an east – west fence line with a N-S fence line. My position agreed within 20' each way of the present authorized POD, and did not see a reason to show a difference with the original tie to the POD. It is my opinion that the section corner is not that definite to argue with the position. The Latitude and Longitude does define the true position of the POD.

**Authority**

**Findings of Fact**

**Background**

1. On February 15, 2008, Steve Sharp filed an application to change the place of use under Certificates 41159 and 46739. The Department assigned the application number T-10540.
2. On November 26, 2008, a revised map was submitted to correctly show the location of the proposed place of use.
3. The portion of the first right to be transferred is as follows:
  - Certificate:** 41159 in the name of LOREN & MARY FLEET (perfected under Permit S-31433)
  - Use:** IRRIGATION of 55.1 ACRES
  - Priority Date:** MARCH 16, 1966
  - Rate:** 0.55 CUBIC FOOT PER SECOND (CFS)
  - Limit/Duty:** ONE-FORTIETH cfs per acre, not to exceed 3.0 acre-feet per acre per year
  - Source:** GRANDE RONDE RIVER, tributary to SNAKE RIVER

This final order is subject to judicial review by the Court of Appeals under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482(1). Pursuant to ORS 536.075 and OAR 137-003-0675, you may petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

7. Notice of the application for transfer was published on February 26, 2008, pursuant to ORS 540.520 and OAR 690-380-4000. No comments were filed in response to the notice.
8. On November 20, 2008, the Department mailed a copy of the draft Preliminary Determination proposing to approve Transfer Application T-10540 to the applicant and his agent. The draft Preliminary Determination set forth a deadline of December 22, 2008, for the applicant to respond. The applicant requested that the Department proceed with issuance of a Preliminary Determination and provided the necessary information to demonstrate that the applicant is authorized to pursue the transfer.
9. On March 25, 2009, the Department issued a Preliminary Determination proposing to approve Transfer Application T-10540 and mailed a copy to the applicant and agent. Additionally, notice of the Preliminary Determination for the transfer application was published on the Department's weekly notice on April 7, 2009, pursuant to ORS 540.520 and OAR 690-380-4020. No protests were filed in response to the notice.

***Transfer Review Criteria [OAR 690-380-4010(2)]***

10. Water has been used within the last five years according to the terms and conditions of the rights, and there is no information in the record that would demonstrate that the rights are subject to forfeiture under ORS 540.610.
11. A pump, pipeline, and sprinkler system sufficient to use the full amount of water allowed under the existing rights were present within the five-year period prior to submittal of Transfer Application T-10540.
12. The proposed change would not result in enlargement of the rights.
13. The proposed change would not result in injury to other water rights.

***Cancellation of a Water Right***

14. An affidavit certifying that a water right has been abandoned and requesting cancellation of the right was received from Steve Sharp on February 15, 2008. The right to be cancelled is as follows:

**Conclusions of Law**


The change in place of use proposed in Transfer Application T-10540 is consistent with the requirements of ORS 540.505 to 540.580 and OAR 690-380-5000, and the abandoned right should be cancelled.

**Now, therefore, it is ORDERED:**

1. The change in place of use proposed in Transfer Application T-10540 is approved. The right that has been abandoned is cancelled.

2. The right to the use of the water is restricted to beneficial use at the place of use described, and is subject to all other conditions and limitations contained in Certificates 41159 and 46739 and any related decree.
3. Water right Certificates 41159 and 46739 and Permit G-16269 are cancelled. A new certificate will be issued describing that portion of Certificate 41159 not affected by this transfer and cancellation.
4. The former place of use of the transferred rights shall no longer receive water under the right.
5. Prior to diverting water, the water user shall install an in-line flow meter, weir, or other suitable device for measuring and recording the quantity of water diverted. The type and plans of the measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department. The water user shall maintain and operate the measuring device as required by the Department.
6. Prior to diverting water, the water user shall install a headgate to control and regulate the quantity of water diverted. The type and plans of the headgate must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department. The water user shall maintain the headgate as required by the Department.
7. The approved change shall be completed and full beneficial use of the water shall be made on or before **October 1, 2010**. A Claim of Beneficial Use prepared by a Certified Water Rights Examiner shall be submitted by the applicant to the Department within one year after the deadline for completion of the change and full beneficial use of the water.
8. When satisfactory proof of the completed change is received, new certificates confirming the rights transferred will be issued.
