has a right to the use of the waters of
BRUSH CREEK TRIBUTARY TO ALSEA RIVER

for the purpose of DOMESTIC USE FOR ONE FAMILY AND IRRIGATION OF 2.0 ACRES.

The right to the use of these waters has been perfected under Permit 38415. The date of priority is JULY 28, 1975. The right is limited to not more than 0.03 CUBIC FOOT PER SECOND; BEING 0.025 CFS FOR IRRIGATION AND 0.005 CFS FOR DOMESTIC or its equivalent in case of rotation, measured at the point of diversion from the source. The point of diversion is located in

LOT 6, SE 1/4 NE 1/4, Section 1, T 14 S, R 10 W, WM; 200 FEET NORTH & 1220 FEET WEST FROM E1/4 CORNER OF SECTION 1

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:




