Your Applications R-66410 and 66411 describing the proposed use of 50.0 acre-feet and 300 gallons per minute of water from an unnamed stream and four reservoirs for irrigation of 50 acres, stock water, fire control, and wildlife, together with the map, have been reviewed.

There are some additions and corrections which are needed before your applications can be considered for issuance of the required permits.

Enclosed are copies of your applications and the map. In red are the corrections to be made. If you agree with the corrections, please make them in dark ink on the original applications and on the map. Here is a rundown of the corrections to be made:

### Application R-66410

- Item 1 - Source is two unnamed streams as shown on the maps.
- Item 3 - Dam 3 located in the NE 1/4 SW 1/4 and Dam 4 located in the NW 1/4 SW 1/4, both in Section 35 as shown on the maps.
- Items 4, 8 - All reservoirs with capacities greater than 9.2 acre-feet or dams greater than 10.0 feet in height must have plans and specifications submitted by a registered professional civil engineer licensed by the State of Oregon. Those reservoirs not exceeding these capacities or dam heights do not. You may wish to revise these items based on this information.
- Item 8 - The total amount of water to be stored must be broken down to the amount of water to be stored in each reservoir.
- Item 9 - Please state number of acres to be submerged by each reservoir.
- Item 7 - Flood management is not considered a beneficial use of water and should be omitted. The total amount of water to be stored in each reservoir must be broken down to the amount of water to be stored in each reservoir for each use.
