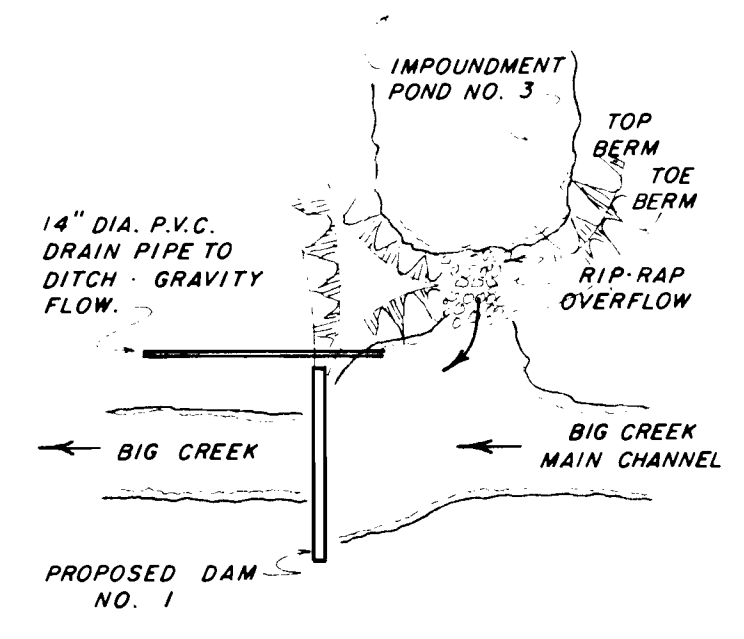
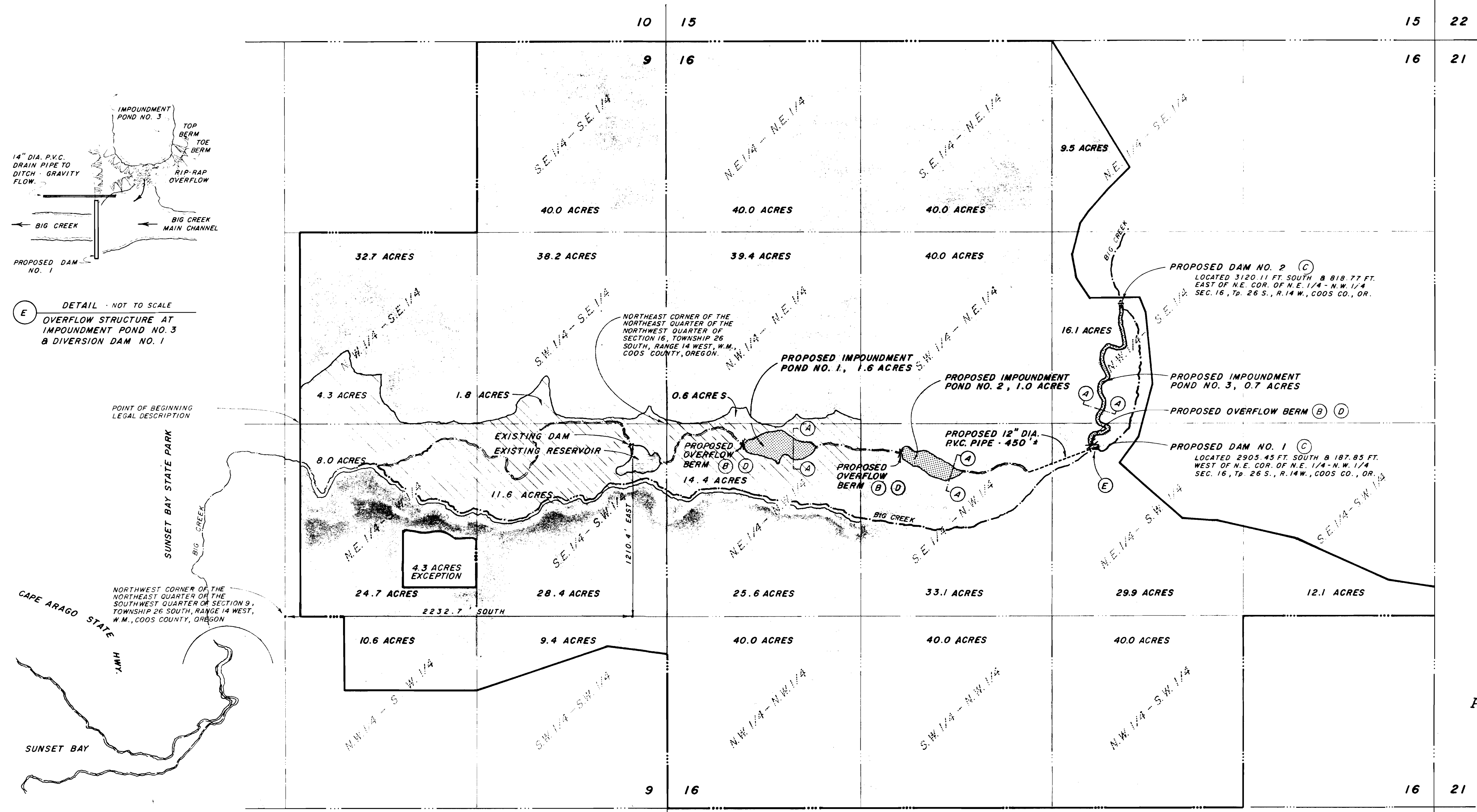
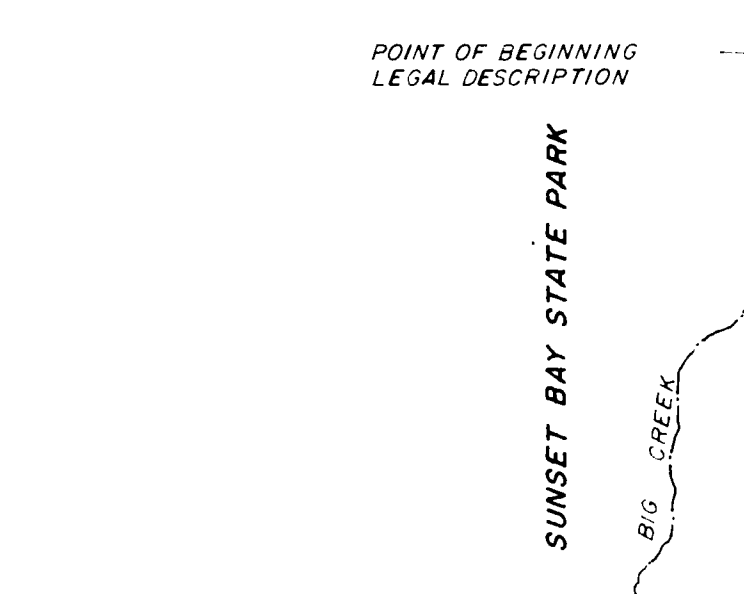


WATER RIGHTS PERMIT APPLICATION - LOCATION MAP

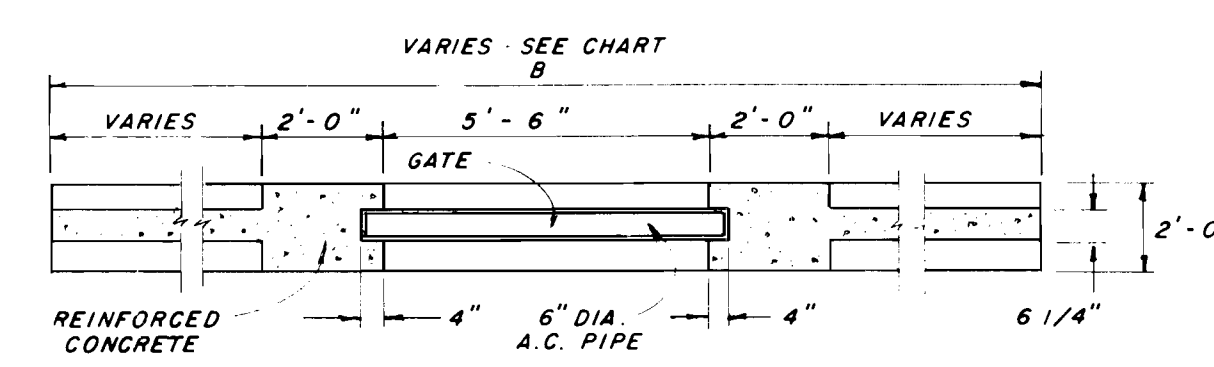

OVERFLOW STRUCTURE AT IMPOUNDMENT POND NO. 3 & DIVERSION DAM NO. 1



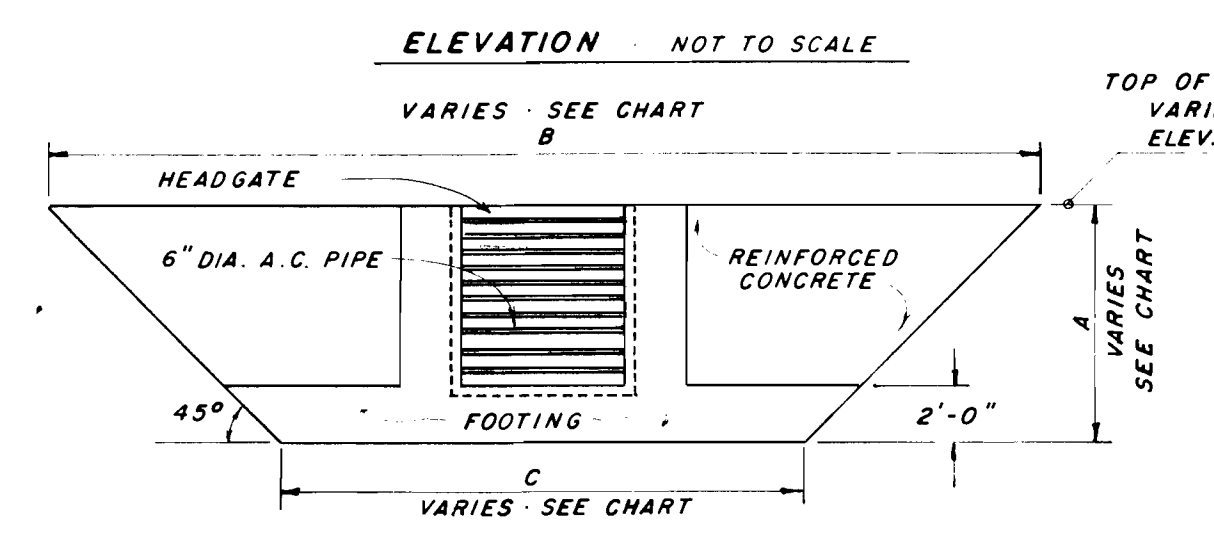
PLAN - NOT TO SCALE

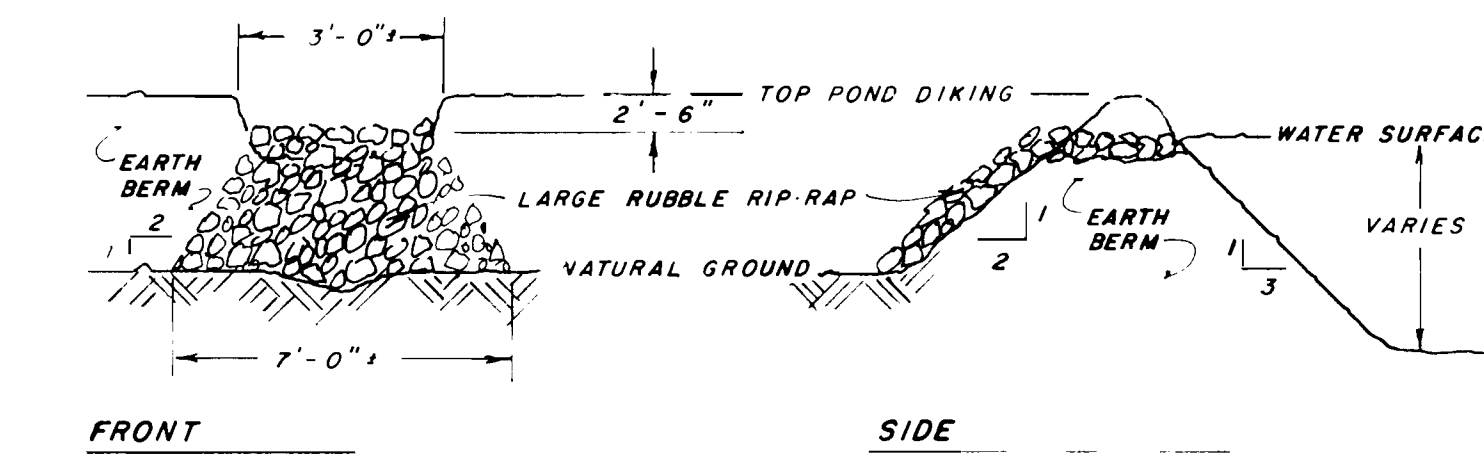

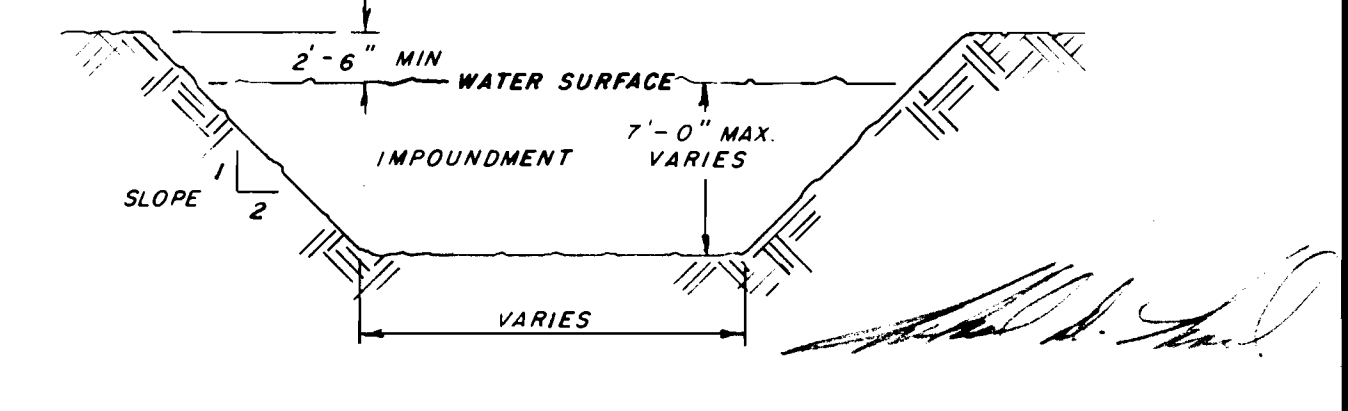
