Appeal Rights

This final order is subject to judicial review by the Court of Appeals under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482(1). Pursuant to ORS 536.075 and OAR 137-003-0675, you may petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

Application History

Permit G-113880 was issued by the Department on February 5, 2004 and modified by Permit Amendment T-13325 on September 22, 2020. Superseding Permit G-18414 was issued by the Department on September 22, 2020, to reflect the changes. The permit specified actual construction of the well to begin by February 5, 2005, and complete application of water to beneficial use by October 1, 2008. The most recent extension authorized completion of construction and complete application of water to beneficial use by October 1, 2020. On August 13, 2021, Threemile Canyon Farms submitted an Application for Extension of Time for Permit G-18414. In accordance with OAR 690-315-0050(2), on March 15, 2022, the Department issued a Proposed Final Order proposing to extend the time to fully apply water to beneficial use to

October 1, 2025. The protest period closed April 8, 2022, in accordance with OAR 690-315-0060(1). No protest was filed.

FINDINGS OF FACT

The Department adopts and incorporates by reference the findings of fact in the Proposed Final Order dated March 15, 2022.

At time of issuance of the Proposed Final Order the Department concluded that, based on the factors demonstrated by the applicant, any comments received, and information within the file, the permit may be extended subject to the following condition:

LIMITATIONS AND CONDITIONS

1. Last Extension Condition

This may be the last extension of time granted for Permit G-18414. Any future extensions of time request may be denied, unless the permit holder can provide the Department with evidence that the required static water level measurements have been submitted annually. No additional extensions of time will be approved to complete the development of any change of place of use or points of appropriation requested in an Application for a Permit Amendment submitted after October 1, 2022. In addition, all normal extension standards and rules will be evaluated. ORS 539.010(5); OAR 690-315-0040.

CONCLUSION OF LAW

The applicant has demonstrated good cause for the permit extension pursuant to ORS 537.630, 539.010(5) and OAR 690-315-0040(2).

ORDER

The extension of time for Application G-14827, Permit G-18414, therefore, is approved subject to conditions contained herein. The deadline for applying water to full beneficial use within the terms and conditions of the permit is extended from October 1, 2020, to October 1, 2025.
