A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

Application History

Permit G-16958 was issued by the Department on September 6, 2012. The permit specified completion of construction and complete application of water to beneficial use by September 6, 2017. On February 28, 2022, Klamath County School District submitted an Application for Extension of Time for Permit G-16958. In accordance with OAR 690-315-0050(2), on May 3, 2022, the Department issued a Proposed Final Order proposing to extend the time to complete construction to October 1, 2023, and the time to fully apply water to beneficial use to October 1, 2023. The protest period closed June 17, 2022, in accordance with OAR 690-315-0060(1). No protest was filed.

FINDINGS OF FACT

The Department adopts and incorporates by reference the findings of fact in the Proposed Final Order dated May 3, 2022.

At time of issuance of the Proposed Final Order the Department concluded that, based on the factors demonstrated by the applicant, any comments received, and information within the file, the permit may be extended subject to no additional conditions.

CONCLUSION OF LAW

The applicant has demonstrated good cause for the permit extension pursuant to ORS 537.630, 539.010(5) and OAR 690-315-0040(2).

ORDER

The extension of time for Application G-17497, Permit G-16958, therefore, is approved. The deadline for completing construction is extended from September 6, 2017, to October 1, 2023. The deadline for applying water to full beneficial use within the terms and conditions of the permit is extended from September 6, 2017, to October 1, 2023.
