## RE: WATER MEASURING DEVICE

This notice is to inform you of the need to install a measuring device at your point of diversion from the creek and from the river. The point of diversion from the Crow Creek and from the North Fork of Siuslaw River identified below do not have an adequate measuring device to allow for proper regulation of water use. Oregon Revised Statutes (ORS) 540.045(1)(a), and OAR 690-250-050, authorizes the watermaster to regulate the distribution of water among users in accordance with existing water rights of record. A workable measuring device at each point of diversion is necessary for water management and to ensure compliance with your water rights.

Your points of diversion authorized by Certificate 19827 are located as follows: on the North Fork of Siuslaw River, SW ¼ SE ¼; on the Crow Creek, SE ¼ SE ¼, as projected on Dillamater D.L.C. #42, Section 12, T. 20 S., R. 5 W., W.M.

ORS 540.310 and OAR 690-250-060, provides the authority for the Department to require the measuring devices. Pursuant to ORS 540.320, the measuring devices must be installed within ten (10) days from the mailing of this notice. After <u>April 20, 2012</u>, the watermaster may regulate off your use of water and prohibit you from diverting water until the approved workable measuring devices are installed and operating properly.

Prior to installation, you are required to get approval from the watermaster for the type and configuration of the measuring device. Facilities shall be of such construction that it can be kept locked and closed by the watermaster. The watermaster may approve an alternate plan or construction schedule under certain circumstances. The watermaster should be contacted if other arrangements are needed.

ORS 540.710 provides that no person shall willfully open, close, change or interfere with any lawfully established headgate or water box or willfully use water or divert water into or through the ditch of the person which has been lawfully denied water by a watermaster or other competent authority. Violation of ORS 540.710 is punishable, upon conviction, by a fine or by imprisonment in the county jail for not more than six months or both, and may also be subject to assessment of civil penalties under ORS 536.900.
