This publication lists agency activities requiring public notice. It also describes public comment processes and deadlines. Types of water use requests in this week's Public Notice include:

- * **Permit Application Initial Reviews, Proposed Final Orders, and Final Orders**
Applications for permits to use, store, divert or pump surface water or groundwater. Includes applications by the state Departments of Fish & Wildlife, Environmental Quality or Parks and Recreation for water to be used and kept in-channel.
- * **Applications for Allocation Of Conserved Water**
Applications made by a water user who conserves water to use a portion of the conserved water on additional lands, lease or sell the water, or dedicate the water to instream use.
- * **Establishment of Mitigation Credits in the Deschutes Basin pursuant to OAR Chapter 690, Division 521 (ORS 537.746)**
- * **Extension of Time Checkpoint Progress Reports filed pursuant to OAR 690-315**
Documents the progress made toward development of the water use project since approval of the last permit extension and/or the last progress report checkpoint. (OAR 690-315 pertains to permit extension applications filed on or after July 1, 2001.)
- * **Application for Instream Lease**
Application by water right holder to lease existing water rights to instream use.
- * **Transfer Applications: Regular**
Requests to change point of diversion or appropriation, place of use, or character of use upon which the public may comment. The changes may be proposed in an application for a transfer (including instream or historic POD), an exchange, or a substitution.
- * **Transfer Preliminary Determinations**
Requests to change point of diversion or appropriation, place of use, and character of use upon which the public may protest the application and Department's preliminary determination.

- * **Transfer Applications: District Permanent for Place of Use - ORS 540.580**
Petitions requesting permanent changes in place(s) of use within a district's boundary.
- * **Transfer Notice: District Permanent Transfers for Place of Use- ORS 540.580(4)**
District notices filed for place of use changes within a district's boundary.
- * **Ground Water Registration Modifications**
Applications requesting Department recognition of changes in point of appropriation, place of use and character of use under a ground water certificate of registration.
- * **Certificate Issuance**
Included in this section is a listing of recently issued water right certificates.

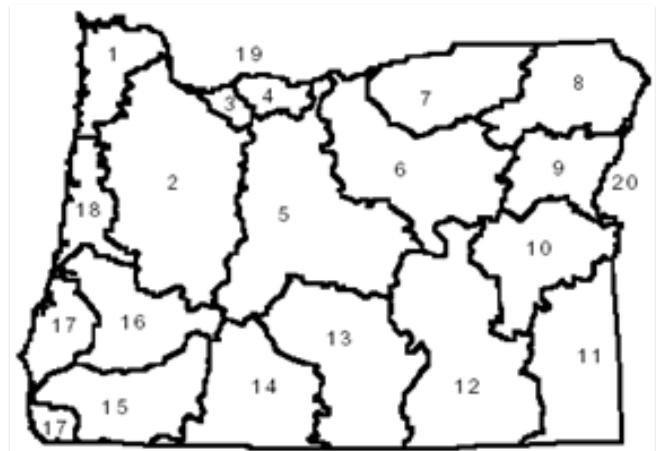

Initial Review and Proposed Final Orders

The following pages of this notice list permit applications that the Department is evaluating for compliance with state water law. Public participation and comment is encouraged. Opportunities for public involvement vary according to the stage of the permit evaluation.

Ground water permit applications in the Deschutes Basin (Basin 5) may seek to provide mitigation pursuant to the Deschutes Ground Water Mitigation Rules.

Initial Review Stage (IR)

The Department has given the applicant an initial review of water-use restrictions, water availability and other limitations that affect the agency's decision on whether to issue a permit. The Department welcomes comments from interested persons, agencies and organizations on the proposed water use. **The comment deadline for initial reviews appearing in this public notice is 5pm, Thursday, August 25, 2022.** Although we cannot respond individually to all comments, each will be considered as the agency makes its decision regarding proposed allocations.

Proposed Final Order Stage (PFO)

The proposed final order is the Department's penultimate decision on the water use request. The PFO documents the agency's decision through specific findings, including review of comments received. If appropriate, it includes a draft permit specifying any conditions or restrictions on the use. Persons interested in receiving a mailed copy of a PFO must pay a statutorily-required fee of \$35. (Any person paying \$35 to receive a PFO by mail will also receive a copy of the Final Order when it is issued.) PFO's may be viewed free of charge online at: <http://apps.wrd.state.or.us/apps/wr/wrinfo/>. Those disagreeing with the Department's decision as expressed in the PFO have 45 days to file a protest.

The protest deadline for proposed final orders appearing in this public notice is 5pm, Friday, September 09, 2022.

The protest filing fee is \$480 for the applicants and \$950 for non-applicants. Detailed requirements for filing a protest are included in the PFO. Persons who support the PFO may file a "standing" fee of \$270 to retain the ability to participate in future proceedings relating to an application. Before participation in a hearing is allowed, an additional \$680 will be required to request to participate as a party or limited party.

If a protest or comment deadline falls on a day that the office is closed, then the next open business day automatically becomes the deadline date.

Applications for Allocation of Conserved Water

The following applications for allocation of conserved water have been received pursuant to ORS 537.455 to 537.500 and OAR Chapter 690, Division 18. In reviewing the applications, the Department will consider whether the diversion for the uses allowed under the original water right will be reduced by the conservation project, whether existing water rights will be protected from injury, and whether the project is in compliance with local comprehensive land use plans.

On May 26, 2022, Raptor Ag LLC, 5201 N Sooner Rd., Edmond, OK 73034, submitted an application for Allocation of Conserved Water under ORS 537.470. Certificate 49202 is for 1.415 cubic foot per second (CFS), 283.0 Acre Feet (AF) from the South Santiam River for irrigation of 113.2 acres in Sec. 3, T11S, R2W, WM, with a priority date of March 8, 1966. The conservation project proposes to convert from big guns to drip emitters. The project proposes to conserve approx. 0.655 CFS, 84.0 AF. The applicant proposes to protect 25% (0.16375 CFS, 21.0 AF) of the conserved water instream.

The project appears to be consistent with the requirements under ORS 537.470. Any interested person may submit written comments for the applications. Comments must be received within 20 days of the last day of publication of this notice, being by 5:00 pm on **August 15, 2022**. Comments should be sent to the attention of the ACW Program, Water Resources Department, 725 Summer Street NE, Suite A, Salem, OR 97301.

Establishment of Mitigation Credits in the Deschutes Basin

ORS 537.746 authorizes the Department to award mitigation credits in the Deschutes Basin to approved mitigation projects. Mitigation credits may be used in the Deschutes Basin, specifically the Deschutes Ground Water Study Area, to mitigate for the impacts of ground water use on surface water flows. Pursuant to OAR Chapter 690, Division 521, upon receipt of notification of a mitigation project, the Department shall give public notice of the intent to establish mitigation credits.

The public is invited to comment on establishment of mitigation credits for the project(s) described below. Comments must be received within 21 days of the date of this public notice. Comments should address the award of mitigation credits to the proposed project and its use for mitigation purposes. Included in this public notice is a preliminary determination as to the amount of mitigation credits that may be available from the proposed project.

Proposed Final Orders Regarding Applications for Extensions of Time for Water Right Permits

ORS 537.230, 537.248, 537.630 and 539.010 authorize the Water Resources Department to extend time limits contained in water right permits for completing construction of water development projects and applying water to full beneficial use. Procedures for permit holders to apply for extensions and for the Department to evaluate and determine whether or not to approve extensions of time are contained in OAR 690-320-0010 for extensions filed before July 1, 2001, and in OAR 690-315-0010 for extensions filed on or after July 1, 2001.

Proposed Final Orders (PFO's) are the Department's preliminary decision on extension requests. They document the agency's decision through specific findings. Persons interested in receiving a mailed copy of a PFO must pay a statutorily-required fee of \$35. (Any person paying to receive a PFO by mail will also receive a copy of the Final Order when it is issued). PFO's may be viewed for free at the Department's Salem Office or at the appropriate watermaster district office.

Extension of Time Public Notice and Comment Procedures

Written comments on or written protests against a PFO must be submitted on or before September 09, 2022. There is no fee for submission of comments. The protest filing fee is \$480 for the applicant and \$950 for non-applicants. Detailed requirements for filing a protest will be sent with copies of the PFO.

OAR 690-077-0077 requires that the Department public notice the lease applications.

The deadline for submitting claims of injury to existing water rights or enlargement of the original right against a lease application is August 16, 2022. Parties to the lease, including the Department, will review any such claims before the lease is finalized. **Notice of Consideration for
Conversion of a Hydroelectric Water Right
To an Instream Right for the Umatilla River**

This process is governed by ORS 543A.305 and OAR 690-054.

Hydroelectric License HE 363 in the name of James B. and Janet A. Boyd was issued for 500 cubic feet per second (cfs) of water from the Umatilla River, tributary to the Columbia River. The diversion point was within the SE ¼ SW 1/4, Section 16, Township 4 North, Range 28 East, W.M., Umatilla County. The priority date for this water right is October 21, 1981.

Use of the water under the hydroelectric water right has ceased for a period of more than 5 years. Oregon Laws 2010 Chapter 63 and Oregon Revised Statutes 543A.305 provide for the conversion of this hydroelectric right to an instream right.

The Director makes a preliminary finding that the full amount of the water right up to 500 cfs is eligible for conversion during the months of December through June. According to the records of the Department, no part of the water right has been transferred under ORS 540.520 or 540.530. During the time of hydroelectric use, all the water was used exclusively for hydroelectric purposes, no part of the right was used in conjunction with another water right, nor in conjunction with multi-purposes dam releases.

The Director makes the following preliminary findings on the potential for injury and whether mitigation measures may be necessary to avoid injury and to ensure the continuation of other authorized water rights as of October 23, 1999.

Concerning actual use of the project: the hydroelectric project actually used up to 500 cfs of water in the months of December through June. In the months of July through November the flashboards were removed from the river to allow bypass flows to be met and no power was generated. Until June 2002 when hydroelectric production ceased, the watermaster managed the gaging station and the timing of the flashboards removal to ensure that bypass flows were met.

Concerning the resulting impacts of the proposed conversion on actual use by other existing water rights as of October 23, 1999: the Department has records of water right certificates and permits that are junior to October 21, 1981 and are upstream of the original point of diversion. A full listing of authorized points of diversion in the Umatilla River basin is available at:

Most (if not all) of the upstream surface water rights are regulated annually by the Watermaster to ensure water is available to serve the senior water right of the West Extension Irrigation District downstream of the hydroelectric project.

The hydroelectric right as originally issued stated: “The right granted herein is expressly made inferior in right and subsequent in time to any appropriation of water from this source for domestic, municipal, irrigation, or any other beneficial consumptive use.” In order to avoid expansion of the original water right, this subordination condition must be included in the conversion of the right to an instream water right. Therefore, the conversion will not injure other existing water rights and no other mitigation measures are necessary as conditions of the instream water right to avoid injury or to ensure the continuation of authorized water uses by other existing water rights.

The Department may convert 500 cfs of water to an instream water right for the months of December through June of each year. The right will be instream at the former diversion point, within the SE ¼ SW 1/4, Section 16, Township 4 North, Range 28 East, W.M., Umatilla County. The right shall be inferior in right and subsequent in time to any appropriation of water from this source for domestic, municipal, irrigation, or any other beneficial consumptive use.

The Department requests comments from interested citizens, organizations, tribal and governmental entities, and other parties on this proposed conversion action. There is a 30-day comment period for any interested person to propose mitigation measures as conditions of the instream water right to avoid injury and to ensure the continuation of authorized water uses by other existing water rights as of October 23, 1999. Comments, questions, or requests to be included on future notices must be received by 5:00 PM on **Thursday, August 25, 2022**.

After the comment period closes, the Department will share information with interested persons about mitigation measures that may have been proposed during the comment period and will meet and confer with those interested persons. The Department may extend the comment period to allow discussion of mitigation measures, and for interested persons to reach agreement. The Department must obtain affidavits consenting to the relevant mitigation measures from each holder of another existing water right as of October 23, 1999, that is potentially subject to new regulation under OAR 690-250 as a result of a conversion to an instream water right.

Consistent with OAR 690-54-0040, the Director will determine whether the conversion, together with any recommended mitigation measures to avoid injury and to ensure the continuation of authorized water uses prior to October 23, 1999, meets the standards of ORS 543A.305 and OAR 690-054. The Director will issue a notice of a proposed order approving or denying the conversion that will start a 60-day period for interested persons to file protests or requests for standing.
