Budget and Legislative Update

I. Introduction

The 82nd Legislative Assembly convened for the 2023 Legislative Session on January 17, 2023. In this informational report, staff will provide an overview of the 2023-2025 Governor's Recommended Budget (GRB) and the 2023 Legislative Session.

II. Budget Development Process and Governor's Recommended Budget

The process to develop and approve state agency budgets starts long before the Oregon Legislature convenes. The Department initiated internal discussions for 2023-2025 budget ideas in late 2021 and began soon after to share our ideas and seek feedback from stakeholders. In the early part of 2022, the Department began building its budget based on instructions provided by the Department of Administrative Services Chief Financial Office (DAS CFO). Budget development for the Department started with the agency's current service level (CSL) budget, which is the current biennium Legislatively Approved Budget with adjustments made to account for expected cost increases such as inflation, while subtracting out items such as one-time costs or programs that are being phased out. Proposed additions and reductions (Policy Option Packages) to the agency's CSL were included in the Department's Agency Request Budget, which was published and submitted to DAS CFO in September 2022.

Thereafter, the Governor's Recommended Budget was developed, using the Agency Request Budgets, the current and projected financial position of the state, budget policies, as well as current law, and Governor's priorities. The GRB was released on January 31, 2023 and serves as the starting point for budget discussions with the Legislature. A summary of the GRB is included in Attachment 1.

As shown in Attachment 1, the 2023-2025 GRB proposes both additions and subtractions to the agency's current service level budget. Reductions total approximately \$5.4 million in General Fund, while additions include \$6.3 million in General Fund resources, of which \$1 million is proposed for the Well Abandonment, Repair, and Replacement fund.

The GRB also includes \$22.3 million in new Lottery Revenue Bond funding to fund Water Project Grants and Loans and Feasibility Study Grants and the cost of issuance. There is \$15.9 million in American Rescue Plan carryover funding also included in the GRB. Staff will brief the Commission on the elements of the Department's GRB during the meeting.

The Department has not yet been scheduled to present its proposed budget to the Ways and Means Subcommittee on Natural Resources. Final action on the Department's budget is not expected until late in the Legislative Session.

III. Overview of 2023 Legislative Session and Deadlines

Water bills are currently being referred to the House Land Use, Agriculture, Natural Resources and Water and the Senate Natural Resources committees. The Department's budget will be heard in the Joint Ways and Means (JWM) Natural Resources Subcommittee; however, bonding bills are traditionally handled by the JWM Capital Construction Subcommittee.

Legislative deadlines are as follows:

- Mar17 Deadline for chairs to post work sessions for first chamber measures.
- Apr 4 Measures must be out of the first chamber committee.
- May 5 Deadline for chairs to post work sessions for second chamber measures.
- May19 Last day for measures to move out of second chamber committees.
- Jun 15 Target adjournment of session sine die.
- Jun 25 Constitutional sine die.

Deadlines generally do not apply to measures in the Ways & Means, Revenue, and Rules committees.

IV. 2023 Legislation

The Department does not have any bills this session; however, the Department is tracking 432 bills as of February 9, 2023. Many of the bills are being tracked due to broad relating to clauses and the potential to be amended to affect Department programs. Attachment 2 provides a select list of those measures that the Department is tracking. Department staff will brief the Commission on some of the more pertinent water measures during the meeting.

V. Conclusion

The Governor's Recommended Budget will now be considered by the Joint Committee on Ways and Means, as well as its subcommittees. Ultimately, the final budget for the Department will be set by the Oregon Legislature. The Constitutional Sine Die deadline for adjournment is June 25. Staff will continue to keep the Commission apprised of important developments through the end of the 2023 Legislative Session.

With some exceptions, most budgetary changes are contained in House Bill 5043 (2023). General Fund = GF, OF=Other Funds, IWRS = Integrated Water Resources Strategy, FTE= Full-Time Equivalent

Package 101 – Facilitate Interagency Work & Implement IWRS – \$371k GF; 1 FTE / 1 positions – IWRS Actions: 6.B, 9.B, 9.C, and 13.A

Makes a limited duration position from the 2021-2023 budget a full-time permanent position to effectively implement the IWRS, develop updates, and ensure coordination and integration among state, federal, and local agencies, as well as educational and non-governmental organizations. Includes \$100k for contracting, ongoing website, communication, and publication costs.

Package 105 – American Rescue Plan Act Carry Over – \$15.9m OF

Carries forward American Rescue Plan Act funding authorized in the 2021-2023 budget in order for those efforts to be completed, including: place-based planning (\$800k); fish passage (\$500k); Ordnance Project in Umatilla County (\$6m); Well Abandonment, Repair, and Replacement Fund (\$1m); support fee-based programs and engagement with stakeholders (\$1.5m); engineering services for flood methodology & inundation assessments (\$2.5m); Water Measurement Cost Share fund (\$1m); and support surface water and groundwater data collection field equipment (\$2.6m). Carryover needs are estimates.

Package 107 – Feasibility Studies, Water Projects, & Wells – \$23.3m Total Funds (\$1m GF; \$22.3m OF) – IWRS Actions: 5.B, 10.E, 13.D, and 13.E

Invests in programs supporting water projects: Water Projects Grants and Loans (\$20m Lottery Revenue Bond proceeds), Feasibility Study Grants (\$2m Lottery Revenue Bond proceeds), the Well Abandonment, Repair, and Replacement Fund (\$1m GF), and cost of issuance.

Package 108 – Water Rights and Protest Backlog Reduction – \$852k GF; 4.00 / 5 positions – IWRS Actions: 10.G and 13.B

Continues investments to reduce water transactions processing times and allow continued progress on the protest backlog. Extends four limited-duration staff (two caseworkers, a protest specialist and an administrative specialist) hired as a result of legislative actions during the 2021 session meant to reduce water right and protest processing

backlogs. Adds one limited-duration water rights processing compliance specialist for providing outreach to applicants with recently approved permits or transfer orders.

Package 110 – Centering Equity in Agency Programs & Policy – \$449k GF; 1.76 FTE / 2 positions – IWRS Actions: 8.B, 8.C, and 9.A

Funds two positions that would be responsible for leading the agency's efforts in advancing environmental and racial justice and diversity, equity and inclusion. These positions will increase the agency's capacity to reach underrepresented and underserved groups, including BIPOC and rural communities, as well as to create a workplace culture that is welcoming and inclusive to all.

Package 111 – Water Use, Supply, and Availability Data – \$1.3m GF; 3.26 FTE / 4 positions – IWRS Actions: 1.B, 5.B, 9.C, and 13.B

Provides initial funding for four positions and contracting services critical for modernizing systems and datasets required to update the Water Availability Reporting model and tool. Contracted services include ongoing funding for the collection of weather data (\$225k BOR Agrimet), ongoing funding for stream gage maintenance (\$200k internal or contracted with USGS), one-time acquisition of gridded weather data (\$10k - PRISM), and one-time funding of temporary storage of data (\$18k Google). The four positions will develop internal tools and applications, research and incorporate new methodologies, collect additional field data, and oversee the integration of these changes into the Department's work.

Package 115 - Supporting Resolution of Complex Issues - \$1.5m GF; - IWRS Action: 9.C

This package includes \$1.5 million in facilitation costs for work related to the Confederated Tribes Umatilla Indian Reservation (CTUIR) water rights settlement.

Package 091 – Additional Analyst Adjustments – Includes funding for agency work in Harney County (\$200k) and for work associated with basin studies (\$600k).

Reductions include the following:

- \$2.9m GF reduction, which increases the Department's Vacancy Savings target to 10.3% of budgeted salaries and wages.
- Reduces funding for evapotranspiration projects in the amount of \$325k (partial reduction of 2021 SB 5561 cannabis package).
- Reduces the Water Measurement Cost Share base budget funding by \$106,511. This only impacts the biennial addition of new GF to the account. ~\$140k Other Fund remains in the account, plus ARPA carryover in POP 105.
- Reduces outreach and facilitation funds by \$450k (from 2021: HB 2018 and Complex issues).
- Reduces groundwater study and observation well funding for by ~\$448k.
- Reduce gaging station funds by \$163k.
- Eliminates two assistant watermasters (\$368k GF) and an evapotranspiration hydrologist (\$206k GF) that was related to cannabis (from 2021 SB 5561)
- Other reductions include adjustments to shared statewide administrative costs including Department of Administrative Services assessments and Attorney General costs in the amount of ~\$408k GF and ~\$58k Other Fund.
