Persons who hold a groundwater right whose groundwater use will may be limited and exempt users whose groundwater use will may be limited as described in the Notice of Proposed Corrective Control Orders will be deemed to have been named parties to the," and **changing 690-010-0190(6) to 690-010-0190(5)**."
