# PUBLIC NOTICE OF WATER USE REQUESTS May 18, 2010

This publication lists agency activities requiring public notice. It also describes public comment processes and deadlines. Types of water use requests in this week's Public Notice include:

- \* Permit Application Initial Reviews, Proposed Final Orders, and Final Orders
  Applications for permits to use, store, divert or pump surface water or groundwater.
  Includes applications by the state Departments of Fish & Wildlife, Environmental
  Quality or Parks and Recreation for water to be used and kept in-channel.
- \* Applications for Limited Licenses

  Requests to use water for 5 years or less. Licenses are subordinate to other rights and may be revoked if a use is found to injure other water right holders.
- \* Applications for Extensions of Time to Perfect Water Right Permits

  New applications received and proposed final orders regarding requests to extend time limits to fully develop water use projects and beneficially apply water.
- \* Emergency Water Use Permit Applications
  Final Orders issued approving applications for temporary water use permits during a drought declared under ORS 536.740.
- \* Application for Instream Lease
  Application by water right holder to lease existing water rights to instream use.
- \* Transfer Preliminary Determinations
  Requests to change point of diversion or appropriation, place of use, and character of use upon which the public may protest the application and Department's preliminary determination.

  Requests to temporarily change place of use and, if necessary to convey the water to the new place of use, to temporarily change the point of diversion or appropriation.

  Petitions requesting transfers in place of use within a district's boundaries.
- \* Establishment of Mitigation Credits in the Deschutes Basin pursuant to OAR Chapter 690, Division 521 (ORS 537.746)
- \* Notice of Intent to Reauthorize a Minor Hydroelectric Project

# Permit Application Initial Reviews and Proposed Final Orders

The following pages of this notice list permit applications that the Oregon Water Resources Department is evaluating for compliance with state water laws and regulations. Public participation and comment is encouraged. Opportunities for public involvement vary according to the stage of the permit evaluation.

Ground water permit applications in the Deschutes Basin (basin 5) may seek to provide mitigation pursuant to the Deschutes Ground Water Mitigation Rules by implementing a mitigation project or by obtaining mitigation credits made available by a completed mitigation project. Surface water and/or reservoir permit applications in the Deschutes Basin may be proposed ground water mitigation projects.

# **Initial Review Stage (IR in the "Stage" column of the permit listing)**

The Department has given the applicant the results of an initial review of water use restrictions, water availability and other limits that affect the agency's decision on whether to issue a permit. The applicant has asked the agency to proceed to the next stage of evaluation. The Department welcomes comments from interested persons, agencies and organizations on the proposed water use.

The comment deadline for initial reviews appearing in this public notice is 5pm, Thursday, June 17, 2010. Although we cannot respond individually to all comments, each will be considered as the agency makes its permit decision.

# Proposed Final Order Stage (PFO in the "Stage" column of the permit listing)

The proposed final order is the Department's preliminary decision on the water use request. It will indicate how the comments received on the application in the first stage were considered. The PFO documents the agency's decision through specific findings. If appropriate, it includes a draft permit specifying any conditions or restrictions on the use. Persons interested in receiving a mailed copy of a PFO must pay a statutorily-required fee of \$20. (Any person paying \$20 to receive a PFO by mail will also receive a copy of the Final Order when it is issued.) PFO's may be viewed for free at the Department's Salem Office or at the district watermaster office nearest the proposed use. Those disagreeing with the Department's decision as expressed in the PFO have 45 days to file a protest.

# The protest deadline for proposed final orders appearing in this public notice is 5pm, Friday, July 02, 2010.

The protest filing fee is \$300 for the applicants and \$600 for non-applicants. Detailed requirements for filing a protest will be sent with copies of the PFO. Persons who support the PFO may file a "standing" fee of \$150 to retain the ability to participate in future proceedings relating to an application. Before participation is allowed, an additional \$300 will be required at the time of the proceeding.

If a protest or comment deadline falls on a day that the office is closed then the next open business day automatically becomes the deadline date. In addition to the usual state or federal office closures, the Oregon Water Resources Department headquarters office will be closed on the following Fridays: October 16, 2009; November 27, 2009; March 19, 2010; April 16, 2010; June 18, 2010; August 20, 2010; September 17, 2010; November 26, 2010; March 18, 2011; and May 20, 2011.



# **Emergency Water Use Permit Applications**

Under OAR 690-19-040, after the Governor declares that a severe, continuing drought exists, the Director may accept applications for emergency use permits.

The Director shall approve an application for emergency water use upon findings that the proposed use will not cause injury to existing water rights and will not impair or be detrimental to the public interest. In evaluating whether the proposed use will impair or be detrimental to the public interest, the Director shall consider the factors described in OAR 690-310-0120 and 690-310-0130; and

- a) The need for water because of the drought emergency; and
- b) The short-term nature of the proposed emergency use.

An emergency use permit may be issued upon approval by the Director. No hearing under ORS 537.170 is required. The Director will consider all comments received concerning the use, or proposed use, under the emergency use permit throughout the life of the permit. Use of water under a emergency use permit may be regulated at any time in accordance with the terms and conditions of the permit. If use of water under a emergency use permit causes injury to an existing water right, the permit shall be revoked unless the injury is mitigated to the satisfaction of the injured water right holder. Any use of water under an emergency use permit shall not exceed the term of the Governor's declared drought or one year.

# **Applications for Limited Licenses**

A limited license allows the right to use or store water for no more than 5 consecutive years. Use of water under a limited license is subordinate to all other authorized uses and may be shut-off at any time to satisfy those other uses. In addition, the Department may revoke a limited license if its use causes injury to any other water right or minimum perennial streamflow.

Licensees must maintain a record of how much water they are using (ORS 537.143). The Department may approve a license after May 31, 2010, upon finding that the proposed water use will not impair or be detrimental to the public interest (OAR 690-340-030). The public is invited to provide comments that will assist the Director in determining whether the use would impair or be detrimental to the public interest.

# Proposed Final Orders Regarding Applications for Extensions of Time for Water Right Permits

ORS 537.230, 537.248, 537.630 and 539.010 authorize the Water Resources Department to extend time limits contained in water right permits for completing construction of water development projects and applying water to full beneficial use. Procedures for permit holders to apply for extensions and for the Department to evaluate and determine whether or not to approve extensions of time are contained in OAR 690-320-0010 for extensions filed before July 1, 2001, and in OAR 690-315-0010 for extensions filed on or after July 1, 2001.

Proposed Final Orders (PFO's) are the Department's preliminary decision on extension requests. They document the agency's decision through specific findings. Persons interested in receiving a mailed copy of a PFO must pay a statutorily-required fee of \$20. (Any person paying to receive a PFO by mail will also receive a copy of the Final Order when it is issued). PFO's may be viewed for free at the Department's Salem Office or at the appropriate district watermaster office.

# **Extension of Time Public Notice and Comment Procedures**

Written comments on or written protests against a PFO must be submitted on or before July 02, 2010. There is no fee for submission of comments. The protest filing fee is \$300 for the applicant and \$600 for non-applicants. Detailed requirements for filing a protest will be sent with copies of the PFO.

Parties to the lease, including the Department, will review any such claims before the lease is finalized. # **Transfer Preliminary Determinations**

A Preliminary Determination provides the Department's conclusion as to whether a proposed change in place of use, point of diversion or appropriation, or character of use of an existing water right should be approved. Changes of water rights may be proposed in an application for transfer (including instream, historic POD, exchange, substitution or ground water registration modification).

The Department has issued preliminary determinations on the transfer applications listed below. In addition to this notice, the Department is complying with ORS 540.520(2) that requires publication of notice in a local newspaper for all transfers except those proposing a change in place of use only or a change in point of diversion of less than ½ mile where there are no intervening diversion points.

Any person may protest the application and preliminary determination or may file a standing statement. Pursuant to OAR 690-380-4030(3) and OAR 690-382-0900, protests must raise all reasonably ascertainable issues and include all reasonably available arguments supporting the person's position. In addition, protests must be accompanied by a \$600 protest fee for non-applicant and \$300.00 protest fee for applicant. A Water Right Transfer Protest Form is available at http://www.oregon.gov/OWRD/PUBS/forms.shtml or by calling 503-986-0888. Protests must be received by the Department on or before June 17, 2010, or within 30 days of the last date of publication in a newspaper, whichever is later. If no protests are filed, the Department will issue a final order consistent with the preliminary determination.

T-9986 filed by Lakeview Water Users, Inc., proposes a change in place of use under Certificates 40196 and 85839 and Permit S-43956. The applicant also proposes to change the point of appropriation and place of use under Certificate 22861. Certificate 85839 allows the use of 0.74 cubic foot per second (priority date January 21, 1907 Drews Creek and July 31, 1908 Cottonwood Creek) from Drews Creek (Sec. 11, T40S, R18E W.M.), Drews Reservoir (Sec. 5, T40S, R18E, W.M.), Cottonwood Creek (Sec. 16, T39S, R19E, W.M.) and Cottonwood Creek Reservoir (Sec. 29, T38S, R19E, W.M.) for IRRIGATION of 20.2 acres in Sec. 13 and 24, T39S, R19E, W.M. Permit S-43956 allows the use of 21.6 acre feet of stored water only (priority date September 5, 1961) from Cottonwood Reservoir for SUPPLEMENTAL IRRIGATION of 20.2 acres in Section 13 and 24, T39S, R19E, W.M. The applicant proposes to change the place of use to Sec. 24. Certificate 22861 allows the use of 0.1 cubic foot per second (priority date March 22, 1950) from a well in Sec. 13, T39S, R19E, W.M. (Thomas Creek Basin) for IRRIGATION of 8.2 acres in Sec. 24. The applicant proposes to add change the point of appropriation approximately 250 feet south (Sec. 24, T39S, R19E, W.M.) and to change the place of use to Sec. 13 and Certificate 26875 allows the use of 0.11 cubic foot per second (priority date May 31, 1950) from Drainage Ditches in Sec. 13, T39S, R19E, W.M. for IRRIGATION of 4.5 acres in Sec. 13. The applicant proposes to change the place of use within Sec. 13, T39S, R19E, W.M.) Certificate 40196 allows the use of 0.24 cubic foot per second (priority date November 3, 1969) from a well in Sec. 13, T39S, R19E, W.M. (Thomas Creek Basin) for IRRIGATION of 19.4 acres in Sec. 24.

The applicant proposes to change the place of use to Sec. 13. The Water Resources Department has concluded that the proposed transfer appears to be consistent with the requirements of ORS Chapter 540 and OAR 690-380-5000.

T-10400 filed by Paula Bond of GB Enterprises, LLC, 21 C Orinda Way, CA, 94563, proposes to change the place of use and point of appropriation under a portion of Certificate 32460. Certificate 32460 allows the use of 0.057 cfs (priority date April 12, 1960) from Well 1 located within the NWSE of DLC 53, Sec. 8, T12S, R4W, W.M., for irrigation in Sec. 8. The applicant proposes to change the point of appropriation to three new wells within DLC 38, being Wells 2 & 3 within the NWNE and Well 4 within the SWNE, Sec. 8, T12S, R4W, W.M. The applicant also proposes to change the place of use to a different configuration within Sec. 8. The Water Resources Department has concluded that the proposed transfer appears to be consistent with the requirements of ORS Chapter 540 and OAR 690-380-5000.

T-10954 filed by KENO WATER COMPANY, c/o GENE COX, PO BOX 771, KENO, OR 97627, proposes an additional point of appropriation and a change in place of use and a change in character of use under Certificate 85625. The right allows the use of 0.33 CUBIC FOOT PER SECOND (priority date SEPTEMBER 19, 1973) from two wells in Sec. 6, T 40S, R 8E, W.M. (Klamath Basin) for DOMESTIC USE for 96 Lots in Sec. 6. The applicant proposes an additional point of appropriation approximately 1000 feet northwest of the nearest well in Sec. 6, T 40S, R 8E, W.M.; to change the place of use to Sec. 24, 25, 26, 35, 36, T 39S, R 7E; Sec. 30, 31, 32, T 39S, R 8E; Sec. 1, 12, T 40S R 7E; and Sec. 6, 7, T 40S, R 8E, W.M.; and to change the character of use to QUASI-MUNICIPAL. The Water Resources Department has concluded that the proposed transfer appears to be consistent with the requirements of ORS Chapter 540 and OAR 690-380-5000.

T-10997 filed by Gary Engle, 37796 Cottonwood Road, Monument, OR 97864 proposes a change in point of diversion under Certificate 946. The right allows the use of 0.25 cubic foot per second (priority date July 2, 1912) from Cottonwood Creek in Sec. 36, T 10 S, R 27 E, W.M. for irrigation in Sec. 25. The applicant proposes to move the point of diversion approximately 1,000 feet upstream to Sec. 36, T 10 S, R 27 E, W.M. The Water Resources Department has concluded that the proposed transfer does not appear to be consistent with the requirements of ORS Chapter 540 and OAR 690-380-5000 because an instream water right would be injured. The Department is proposing to DENY transfer application T-10997 unless Oregon Department of Fish and Wildlife and Oregon Parks and Recreation Department recommend consent to injury of the instream water right due to net benefit from the proposed change.

T-11004 filed by DAN MCCARTY, 27471 MCCARTY RANCH LANE, ECHO, OR 97826 proposes an additional point of appropriation under Certificates 50853 and 52005. Certificate 50853 allows the use of 5.26 CUBIC FEET PER SECOND (priority date NOVEMBER 5, 1973) from a well in Sec. 36, T 2 N, R 24 E, W.M. (Willow Creek Basin) for IRRIGATION in Sec. 36. Certificate 52005 allows the use of 2.61 CUBIC FEET PER SECOND (priority date MARCH 29, 1974) from a well in Sec. 36, T 2 N, R 24 E, W.M. (Willow Creek Basin) for IRRIGATION in Secs. 1 and 2, T 1 N, R 24 E, W.M. The applicant proposes an additional point of appropriation approximately 0.33 miles southwesterly in Sec. 36, T 2 N, R 24 E, W.M. The Water Resources Department has concluded that the proposed transfer appears to be

consistent with the requirements of ORS Chapter 540 and OAR 690-380-5000.

T-10566, originally filed by MELANIE WEEKS, now assigned to new landowner Mr. Tom Penner, 43731 Jerico Lane, Pendleton, OR 97801, proposes a change in place of use and point of appropriation under a portion of Certificate 53749. The right allows the use of 0.025 cfs (priority date June 27, 1980) from a well within the McKay Creek Basin located in Sec. 34, T2N, R32E, W.M., for IRRIGATION in Sec. 34. The applicant proposes to change the point of appropriation northwest approximately 1000 feet to two wells within the SW1/4 NE1/4 of Sec. 34, and to change the place of use of 2.0 acres to within the same SW1/4 NE1/4 of Sec. 34. The Water Resources Department has concluded that the proposed transfer appears to be consistent with the requirements of ORS Chapter 540 and OAR 690-380-5000.

# **Transfer Applications: Temporary Transfer**

The holder of a water right subject to transfer may request to temporarily change the place of use of the water for up to 5 years and, if necessary to convey the water, to temporarily change the point of diversion or appropriation. The Department shall approve the request provided it does not cause injury to existing water rights or expand the water use. If after the change is approved, it is found to cause injury, the approved change may be revoked. The use of water reverts to the authorized place of use upon expiration of the temporary change.

# **District Permanent Transfers (ORS 540.580)**

A district may request to permanently change the place of use within district boundaries. A district may provide notice to the Department of a change before it is made, and shall submit a district permanent application prior to the end of the calendar year in which the change occurs. The Department shall approve the transfer application provided it does not cause injury to existing water rights or expand the water use. The final order approving the permanent transfer is subject to protest.

This public notice also includes district notices of proposed changes. The Department will accept comments on injury and enlargement of changes in place of use associated with the notice and use those comments in the review of the proposed change.
