SALEM-- The Water Resources Commission's Ground Water Advisory Committee (GWAC) will meet on Friday, February 10, 2006 at 9:00 a.m. The GWAC will meet in the Rogue Conference Room, North Mall Office Building, 725 Summer St NE, Salem.

New Member Introduction

The Water Resources Commission recently appointed Greg Kupillas to GWAC. Greg is a consulting hydrogeologist with Pacific Hydro-Geology of Mulino, Oregon and will serve a three-year term through November 2008.

Election of New GWAC Officers

The administrative rules for the committee in OAR 690-235 provide for the committee to select one of its members as Chair and another as Vice-Chair. Maximum terms of officers shall be two years for each position within six consecutive years.

2006 Rulemaking Activities and 2007 Legislative Concept Development

Debbie Colbert, Senior Policy Coordinator, will update GWAC on the Department's anticipated rulemaking activities for 2006. Debbie will also discuss the Department's efforts and timelines for developing legislative concepts for the 2007 legislative session.

Division 217 Rulemaking

Mike Zwart, Hydrogeologist and/or Doug Woodcock, Ground Water Section Manager, will present proposed amendments to the Division 217 pump test rules for GWAC discussion and input. The proposed amendments would waive the pump test requirement for certain permits and certificates, unless required by the Director.

Divisions 200, 205, 220, 225, and 240 Rulemaking

Kris Byrd, Well Construction Specialist, will present proposed amendments to the well construction licensing and bonding rules (Divisions 200, 205, 220, 225, and 240) for GWAC discussion and input. The proposed amendments implement Senate Bill 579 passed in 2001 which directed the Department to adopt a single water well constructor license no later than July 1, 2006.

Online Filing of Well Logs

Ken Smith, computer programmer, will describe the Department's new tools for filing well logs online. He will describe how to access the forms, set up an account, and get started.

Klamath Basin Ground Water Study

Ken Lite, Hydrogeologist, will present information on the cooperative ground water study in the Klamath Basin. The USGS and WRD are in the midst of a multi-year investigation.

Measure 37 and the Water Resources Department

Kim Grigsby, Water Resources Policy Analyst, will present information on Measure 37 and specific claims that targeted the Water Resources Department. Claims targeting county land use restrictions could result in an increase of rural residential developments. Doug Woodcock will discuss the associated issue of ground water monitoring and regulating of rural community water systems.
