Introduction of New GWAC Members

The Water Resources Commission recently appointed Lynne Paretchan and Bob Jones to GWAC. Lynne is an attorney with Perkins Coie LLP of Portland, Oregon, where she works with water rights, land use, and other matters. Bob Jones is a hydrogeologist with the Medford Water Commission, providing technical assistance. Both will serve three-year terms through November 2009.

Welcome to New GWAC Members

Phillip Ward, Water Resources Department Director, will welcome new members to the committee. He will also be available to speak briefly to GWAC on water matters of concern to members.

Legislative, Budget, Commission, and Rulemaking Update

Debbie Colbert, Senior Policy Coordinator, will provide a brief update on draft legislation, the Department's proposed budget, Water Resources Commission activities, and agency rulemaking.

Water Right Forfeiture Process

Juno Pandian, Enforcement Manager, will present the process for the forfeiture of a water right. In Oregon law, a water right may be forfeit if it undergoes several years of non-use. At the last GWAC meeting, the committee asked for more information about forfeiture. The topic arose in the context of a Department sponsored fee bill that relates to the subject.

Issues Involved with Water Right Splitting to Ownership

Water rights staff will discuss this issue that was raised by GWAC member, Greg Kupillas, at the last meeting. At issue are the water right problems that occur under the existing structure when landownership splinters to multiple owners. These include water right perfection issues, extension issues, and additional work for the Department and landowners.
