Place-Based Water Planning (PBP)



Place-Based Water Planning

PBP is IWRS Recommended Action
 PBP Draft Guidelines developed
 PBP Draft Guidelines piloted across state
 First Place-Based Water Plans recognized by Commission
 Independent Evaluation of PBP Pilot
 State-Supported Regional Water Planning and Management Workgroup (HB 5006)



Place-Based Water Planning

Place-Based Water Planning legislation passed

ORS 537.872

Establishes Place-Based Water Planning Fund

ORS 537.873

2023

- Defines place-based integrated water resources plan/planning
- Provides granting, contracting, and rulemaking authority
- Describes requirements for interagency consultation, state recognition, and notification



Place-Based Water Planning

Draft PBP rules developed
 Rules Advisory Committee convened
 Interagency staff team convened
 Division 602 Rules proposed for adoption
 PBP guidelines released (anticipated)
 First PBP grant solicitation (anticipated)
 PBP Technical Assistance strategy and products released (anticipated)

Rulemaking Process

Tribal Engagement

- Sent Government-to-Government letters/emails inviting coordination and consultation on rules and solicitation for RAC membership
- Staff-to-Staff Cultural Resources Cluster and Natural Resources Workgroup:
 - Invited informal and formal engagement
 - Provided updates



Proposed Rules



Purpose (-0100)

- Establishes procedures for:
 - OWRD's administration of the Place-Based Water Planning Fund and program
 - The process and consideration of state-recognized place-based integrated water resources plans by the Department and in Oregon's Integrated Water Resources Strategy (IWRS)



Definitions (-0200) (selected examples below)

Collaborative

- Balanced representation of instream and out-of-stream water interests from the community
- Develop, implement, or update a plan

Community

- People impacted by the water resources of the planning area
- Entities with an interest or obligation related to water resources or ecosystems in or impacted by the planning area
- Federal, state, local, and tribal governments



Grant Application Process (-0300)


- Similar to other OWRD grants
- Timing of grant solicitation will depend on:
 - Availability of funds and
 - State agency capacity to support grantees and planning processes
- Department may use interagency application review team
- Director awards grants per statute



Eligible Grant Types (-0400)

- Planning Readiness Evaluation and Preparation (PREP) Grants
- Plan Development Grants
- Post Plan Coordination Grants
- Plan Update Grants






Match Requirements (-0500)

- Similar to other OWRD match requirements
- Match requirements included in announcement of grant funding cycles (not to exceed 50%)
- Match must be secured within 18 months from date of award
- In-kind labor considered match (includes volunteer time)



Grant Evaluation Criteria (-0600)

- Ability to add evaluation criteria based on lessons learned
- All grant types shall be evaluated on:
 - Approach to public participation and engagement of EJ communities
 - Strategic priorities identified grant solicitation materials








Grant Evaluation Criteria (-0600) cont'd

PREP Grants

- Commitment/ability to engage a balance of instream and out-of-stream water interests
- Need to assess readiness/ prepare for PBP



Grant Evaluation Criteria (-0600) cont'd

Plan Development Grants

- Ability to meaningfully engage and collaborate in a neutral process over multiple years
- Proposed data, technical information, and planning tools
- Value of and need for PBP


OREGO'N Agency Capacity to support plan development



Grant Evaluation Criteria (-0600) cont'd

Post Plan Coordination Grants

- Pursuit of implementation represents:
 - Balance of instream and out-of-stream water interests
 - Commitment to collaboration and PBP principles
- Progress made towards Plan implementation






Grant Evaluation Criteria (-0600) cont'd

Plan Update Grants

- Pursuit of implementation represents:
 - Balance of instream and out-of-stream water interests
 - Commitment to collaboration and PBP principles
- Need for an update





Grant Agreement and Conditions (-0700)

- Similar to other OWRD grants
- Grantee must also:
 - Ensure a collaborative process
 - Adhere to principles of PBP and IWRS
 - Follow the process, content, and structure provided by Department
 - Pursue state-recognition

Distribution of Grant Funds (-0800)

• Similar to other OWRD grants



State Recognition of Plans (-0900)

Process to obtain state-recognition

- Adopted by collaborative through consensus
- Reviewed by interagency Plan Review Team
- Recognized by Commission

Process to maintain state-recognition

Biennial progress reports

State Recognition of Plans (-0900)

Agency support of state-recognized plans:

Agencies identify, document, and communicate to collaboratives which plan strategies may be supported by those agencies

Relationship to the IWRS:

Agencies identify and may incorporate common themes, critical issues, or individual strategies into updates and any associated workplans

Public Notice and Comment (-1000)

For **grant awards** and **state recognition decisions**:

- Public notice with minimum 45-day public comment period
- Written notice to county and Tribal governments within a planning boundary

Agreements or Contracts (-1100)

- Requires an interagency report every four years that:
 - Identifies purposes for agreements/contracts
 - Documents spending on agreements/contracts
- Reiterates authority to use funds for purposes consistent with statute



Provision of Technical Assistance (-1200)

 Requires interagency system for responding to PBP Technical Assistance requests

Program Evaluation (-1300)

Requires periodic program evaluation



Comments & Responses



Comments Received

- Written and oral comments received from:
 - 2 Tribes
 - 9 individuals/groups
- Tribal comments and majority of public comments received were in support of proposed rules



Summary of Tribal Comments

Theme	Department Response
Ensure meaningful engagement from disadvantaged communities and regulatory agencies.	State agency roles and community engagement will be discussed in the PBP Handbook.
Interest in joining the Application Review Team to contribute their historical and technical expertise.	 Tribes are eligible recipients of grant awards, they would not serve on an Application Review Team but Tribes will be contacted directly if they are within the proposed planning boundary of an application and invited to provide input.

Summary of Public Comments

Theme	Department Response
Not enough requirements in rule for frequency of different program elements	Improves adaptability of program to respond to program needs
Proposed rules will help provide needed standards for place-based water planning but more is likely needed	Additional standards will be outlined in more detail in guidance
There is the potential to exclude instream interests from the planning process	Representing instream interests is definitional to PBP



Summary of Public Comments

Theme	Department Response
Proposed rule language is confusing and adequate public and Tribal notice of the rulemaking process was not given	 PBP guidance will meet standards for readability and comprehension Notice fulfilled all requirements



Fiscal and Racial Equity Impacts



Fiscal Impact

- Rules may positively impact Oregon economy through funding of eligible place-based planning collaboratives and contracts
- May have varying impacts on planning participants, including state agencies, governments, organizations, and members of the public

Racial Equity Impact

- Grants may assist with building capacity of a community to engage in PBP
- Proposed rules may foster more inclusive and equitable water resource management, leading to a more secure water future for impacted communities
- Relationship to IWRS offers opportunity for diverse voices to have a further reaching impact in statewide planning efforts
- No unintended adverse consequences on racial equity are expected from proposed rules
