A. <u>Water Project Grants and Loans and Irrigation Modernization Funding Recommendations</u> Adair Muth, Grants Manager, and Kim Fritz-Ogren, Planning, Collaboration, and Investments Section Manager, presented the Technical Review Team's scoring results, evaluation summaries, funding recommendations, and public comments received for the second 2024 funding cycle of Water Project Grants and Loans and Irrigation Modernization Funding.

B. <u>Water Supply Development Account Grant Increase Delegation of Authority</u>

Adair Muth, Grants Manager, and Kim Fritz-Ogren, Planning, Collaboration, and Investments Section Manager, presented a proposal for the Commission to grant the Director the authority to increase grant budgets for previously awarded projects in the Water Supply Development Account.

Commissioner Moll moved to authorize the Director or their designee to increase water grant budgets for projects previously awarded funds by the Commission from the Water Supply Development Account of up to 10% of the initial grant award but not to exceed \$250,000, noting Chair Quaempts' recommendation of regular reporting to the Commission. Chair Quaempts had asked that staff report on increases in the Director's report, in the following quarter after an increase is approved. It was further amended to note that this would be a one-time opportunity to request an increase.
