- Develop and through rule recognize community engagement best practices for water projects
- Department funded community engagement plans use recognized best practices

Public Comment Opportunity - Feasibility Study Grants

The Oregon Water Resources Department (OWRD) invites written public comment on applications received for the 2023-2024 cycle of Feasibility Study Grants. This opportunity funds studies to evaluate the feasibility of developing water conservation, reuse, and storage projects. OWRD received four complete grant applications requesting a total of \$285,179. A multi-agency review team reviewed each application and recommends funding three of the four applications.

Written comments on the applications will be accepted until 5 p.m. on March 7, 2024.

- No anticipated impacts to racial equity.




Implementation - Feasibility Study Grants

- Summer 2025 Develop guidance documents
- Fall 2025 Announce funding cycle
- Spring 2026 Grant applications due

Tribal Engagement

Before and During Rulemaking Process:

- Invited informal and formal engagement and provided updates via Staff-to-Staff Cultural Resources Cluster and Natural Resources Workgroup
- Sent Government-to-Government letters/emails inviting coordination and consultation on development of the rules, and solicitation for RAC membership
- Distributed the notice of proposed rulemaking
