This publication lists agency activities requiring public notice. It also describes public comment processes and deadlines. Types of water use requests in this week's Public Notice include:

- * **Permit Application Initial Reviews, Proposed Final Orders, and Final Orders**
Applications for permits to use, store, divert or pump surface water or groundwater. Includes applications by the state Departments of Fish & Wildlife, Environmental Quality or Parks and Recreation for water to be used and kept in-channel.
- * **Applications for Extensions of Time to Perfect Water Right Permits**
New applications received and proposed final orders regarding requests to extend time limits to fully develop water use projects and beneficially apply water.
- * **Applications for Limited Licenses**
Requests to use water for 5 years or less. Licenses are subordinate to other rights and may be revoked if a use is found to injure other water right holders.
- * **Application for Instream Lease**
Application by water right holder to lease existing water rights to instream use.
- * **Transfer Applications: Regular**
Requests to change point of diversion or appropriation, place of use, or character of use upon which the public may comment. The changes may be proposed in an application for a transfer (including instream or historic POD), an exchange, or a substitution.
- * **Transfer Proposed Final Orders**
Requests to change point of diversion or appropriation, place of use, and character of use upon which the public may protest the application and Department's proposed final order.
- * **Water Management and Conservation Plan Progress Reports**
Water management and conservation plan progress reports submitted by municipalities under provisions of OAR Chapter 690, Division 86.

* **Certificate Issuance**

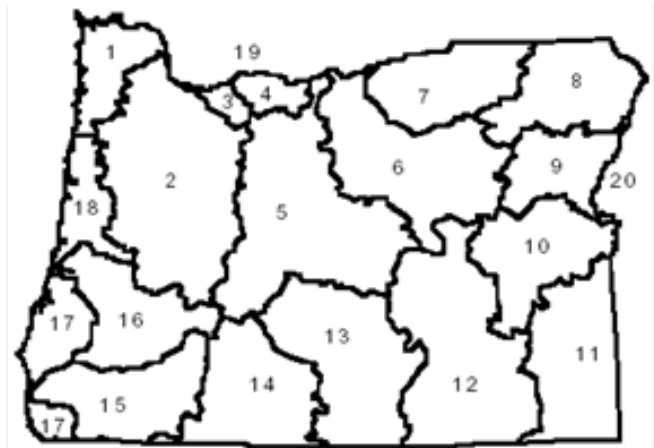

Initial Review and Proposed Final Orders

The following pages of this notice list permit applications that the Department is evaluating for compliance with state water law. Public participation and comment is encouraged. Opportunities for public involvement vary according to the stage of the permit evaluation.

Initial Review (IR) Stage

The Department has given the applicant an initial review of water-use restrictions, water availability and other limitations that affect the agency's decision on whether to issue a permit. The Department welcomes comments from interested persons, agencies and organizations on the proposed water use. **The comment deadline for initial reviews appearing in this public notice is 5pm, Thursday, February 26, 2026.** Although we cannot respond individually to all comments, each will be considered as the agency makes its decision regarding proposed allocations.

Proposed Final Order (PFO) Stage

The proposed final order is the Department's penultimate decision on the water use request. The PFO documents the agency's decision through specific findings, including review of comments received. If appropriate, it includes a draft permit specifying any conditions or restrictions on the use. Persons interested in receiving a mailed copy of a PFO must pay a statutorily-required fee of \$53. (Any person paying \$53 to receive a PFO by mail will also receive a copy of the Final Order when it is issued.) PFOs may be viewed free of charge online at: <http://apps.wrd.state.or.us/apps/wr/wrinfo/>. Those disagreeing with the Department's decision as expressed in the PFO have 45 days to file a protest. Detailed information related to filing a protest can be found within the PFO.

The protest deadline for proposed final orders appearing in this public notice is 5pm, Friday, March 13, 2026.

If a protest or comment deadline falls on a day that the office is closed, then the next open business day automatically becomes the deadline date.

Applications for Limited Licenses

A limited license allows the right to use or store water for no more than 5 consecutive years. Use of water under a limited license is subordinate to all other authorized uses and may be shut-off at any time to satisfy those other uses. In addition, the Department may revoke a limited license if its use causes injury to any other water right or minimum perennial streamflow.

Licensees must maintain a record of how much water they are using (ORS 537.143). **The Department may approve a license after February 10, 2026, upon finding that the proposed water use will not impair or be detrimental to the public interest (OAR 690-340-030).** The public is invited to provide comments that will assist the Director in determining whether the use would impair or be detrimental to the public interest. If the applicant applies for a use that is not one of the standard uses listed in OAR 690-300, the Department may, for the purposes of this notice, assign a named use that is reasonably close to the use actually requested. The public may examine the actual application by clicking the associated hyperlink and then choosing "LL Application" under "Scanned Documents."

Applications for Instream Lease

ORS 537.348 authorizes a water right holder to lease their existing water right(s) to instream use for a limited time. For the term of the lease, the water right holder agrees to suspend use of water under the original right. The state is the trustee for water rights leased for instream use. OAR 690-077-0077 requires that the Department public notice the lease applications.

The deadline for submitting claims of injury to existing water rights or enlargement of the original right against a lease application is February 17, 2026. Parties to the lease, including the Department, will review any such claims before the lease is finalized. Transfer Proposed Final Order

A Proposed Final Order provides the Department's conclusion as to whether a proposed change in place of use, point of diversion or appropriation, or character of use of an existing water right should be approved. Changes of water rights may be proposed in an application for transfer (including instream, historic POD, exchange, substitution or ground water registration modification).

The Department has issued proposed final orders on the transfer applications listed below. In addition to this notice, the Department is complying with ORS 540.520(5) that requires publication of notice in a local newspaper for all transfers except those proposing a change in place of use only or a change in point of diversion of less than ¼ mile where there are no intervening diversion points between the authorized and proposed points of diversion.

Any person may protest a proposed final order to request a contested case hearing on the proposed final order. Protests must meet the requirements of Oregon Laws 2025, chapter 575, section 3a(1), 3a(3)(b), and 3a(3)(c), including being accompanied by a \$1,425 protest fee for a nonapplicant and \$720 protest fee for an applicant. Protests must be received by the Department on or before February 26, 2026 (being 30 days from the date of this notice). If a protest is filed, any person who supports the proposed final order may file a request for party status to request to participate in any contested case proceeding in support of the proposed final order. Requests for party status must meet the requirements of Oregon Laws 2025, chapter 575, section 3a(2)(b), including being accompanied by \$1,425 request for party status fee. Requests for party status must be received by the Department within 30 days after the deadline for filing a protest. For additional information concerning protests and requests for party status, review the information included in the proposed final order or call the Protest Program Coordinator at (503) 507-2749.

[T-13618](#) filed by Trout Unlimited, 1453 Esplanade Ave., Klamath Falls, OR 97601, proposes a change in point of diversion under Certificates 1091, 1094, 1104, 1107, 1108, 1109, and 1111. Certificate 1091 allows the use of 3.26 cubic feet second (cfs) from April 1st to July 20th of each year and thereafter until the close of the irrigating season 1.63 cfs from Anna Creek for irrigation in Sects. 8 and 9, T33S, R7.5E, WM. Certificate 1094 allows the use of 0.85 cfs from April 1st to July 20th of each year and thereafter until the close of the irrigating season 0.43 cfs from Anna Creek for irrigation in Sec. 9, T33S, R7.5E, WM. Certificate 1104 allows the use of 2.00 cfs from April 1st to July 20th of each year and thereafter until the close of the irrigating season 1.00 cfs from Anna Creek for irrigation in Sec. 21, T33S, R7.5E, WM. Certificate 1107 allows the use of 3.83 cfs from April 1st to July 20th of each year and thereafter until the close of the irrigating season 1.91 cfs from Anna Creek for irrigation in Sec. 16, T33S, R7.5E, WM. Certificate 1108 allows the use of 2.00 cfs from April 1st to July 20th of each year and thereafter until the close of the irrigating season 1.00 cfs from Anna Creek for irrigation in Sects. 8 and 9, T33S, R7.5E, WM. Certificate 1109 allows the use of 0.50 cfs from April 1st to July 20th of each year and thereafter until the close of the irrigating season 0.25 cfs from Anna Creek for irrigation in Sec. 21, T33S, R7.5E, WM. Certificate 1111 allows the use of 3.53 cfs from April 1st to July 20th of each year and thereafter until the close of the irrigating season 1.76 cfs from Anna Creek for irrigation in Sects. 16 and 21, T33S, R7.5E, WM. The applicant proposes to move the point of diversion within Sec. 5, T33S, R7.5E, WM. The Water Resources Department proposes to deny the transfer, based on the requirements of ORS Chapter 540 and OAR 690-380-5000.

The applicant proposes a change in point of diversion approximately 420 feet upstream on Anna Creek in Sec. 5, T33S, R7.5E, WM. The Water Resources Department determined that the transfer would injure instream water right Certificate 73392. The Oregon Department of Fish and Wildlife (ODFW) concluded that the transfer would result in net benefits to the resource if conditioned as follows:

- a) ODFW recommends the transfer applicant comply with terms of the associated Mitigation Plan to minimize detrimental impacts to fish, wildlife, and/or their habitat. ODFW understands that the mitigation and following conditions will be fully incorporated into the requirements of the new certificate and may only be altered by written mutual agreement of all parties. ODFW recommends:
 - i. Regulation of the use and/or cancellation of the certificate(s) if the required mitigation is not maintained.
 - ii. This recommendation to consent to injury is contingent upon the push up dams being removed and an ODFW-approved fish screen installed prior to diversion of water at the new POD
- b) The permittee shall not construct, operate, or maintain any dam or artificial obstruction to fish passage without obtaining approval from the Oregon Department of Fish and Wildlife (ODFW). The permittee is hereby directed to contact an ODFW Fish Passage Coordinator prior to construction of any in-channel obstruction or prior to diversion of water that may create an artificial obstruction due to low flow.
- c) The permittee shall install, maintain, and operate fish screening on the new point of diversion consistent with current Oregon Department of Fish and Wildlife (ODFW) standards. Fish screening is to prevent fish from entering the proposed diversion. The required screen is to be in place and functional and approved in writing by ODFW prior to diversion of water. The permittee is hereby directed to contact the ODFW Fish Screening Coordinator prior to diversion of water.
- d) If the riparian area is disturbed in the process of developing the new point of diversion, the permittee shall be responsible for restoration and enhancement of such riparian area in accordance with the Oregon Department of Fish and Wildlife's Fish and Wildlife Habitat Mitigation Policy OAR 635-415. Prior to development of the new point of diversion, the permittee shall submit, to the Oregon Water Resources Department, a Riparian Mitigation Plan approved in writing by ODFW unless ODFW provides documentation that riparian mitigation is not necessary. The permittee shall maintain the riparian area for the life of the permit and subsequent certificate per the approved Riparian Mitigation Plan. If ODFW determines the riparian area is not being maintained and is unsuccessful in working with the water user to fulfill the obligation, ODFW may request that OWRD regulate the use of water until OWRD receives notification from ODFW that the mitigation is sufficient. The permittee is hereby directed to contact the local ODFW Fish Biologist prior to development of the new point of diversion.
- e) Construction must occur during the established in-water work period (August 1 – September 30) unless otherwise approved by ODFW.
- f) Ensure that the portable pump and associated equipment are free from invasive species if being moved from another waterway.

Copies of the OWRD's Preliminary Determination proposing approval of the transfer and ODFW's recommendations are available for viewing at the Salem office of the Water Resources Department. Any person may review the recommendation and submit written comments or may submit a written request for a public meeting to review the recommendation. The comments or request for a meeting must be received by OWRD on or before February 26, 2026.

OWRD will provide copies of any comments submitted in response to this notice to ODFW. If a meeting is requested, OWRD will schedule a joint public meeting with ODFW to review the recommendation.
