Chair Thorndike called the meeting to order and began by asking Vice-Chair Nakano to welcome everyone to his area of the state.

Commissioner Nakano recognized members of the audience for their attendance at the meeting including Representative Denny Jones; Kelly Reediman, Malheur Watershed Council; and Larry Myers, Argus Observer.

Commissioner Nakano thanked Jay Chamberlain, Owyhee Irrigation District, for the tour of the Owyhee Dam earlier that day. The Commission also enjoyed the tour of the Amalgamated Sugar Plant in Nyssa that same day.

Commissioner Nakano also welcomed work session panelists Dave Castleberry, Warm Springs Irrigation District; Jennifer Martin, Owyhee Watershed Council; Jay Chamberlain, Owyhee Irrigation District; and Dr. Clinton Shock, OSU Malheur Experiment Station.

Malheur and Owyhee Basins Water Management Issues A.

Jerry Rodgers, Eastern Region Manager, welcomed the Commission to the Eastern Region. Rodgers explained that the panelists would be discussing local water issues within Malheur County.

Panelists included Dave Castleberry, Warm Springs Irrigation District; Jennifer Martin, Owyhee Watershed Council; Jay Chamberlain, Owyhee Irrigation District; and Dr. Clinton Shock, OSU

Malheur Experiment Station. Each panelist spoke on their experiences with water issues during short water years.

Jerry Rodgers wrapped up the panel discussion by stating that the Commission was able to get a view of some of the irrigated agriculture in the region, but that there were many more miles of area that the Commission was not able to see.

Commissioner Hansell commented that it is important, as a Commissioner, to be able to get out and see the state and see what is happening. He also said that it is important to hear what kinds of problems are out there also.

Commissioner Thorndike expressed the importance that the community maintain an active role in working with and educating policy makers in terms of coming up with approaches and systems that work.
