Committee member will make a public announcement and explain necessary procedures.

**\*Public Testimony:** The Cont. Ed. Committee encourages public comment on any agenda item. However, public testimony may be limited on items marked with an asterisk (\*). The asterisk means that the item has already been the subject of a formal public hearing or contested case hearing. On certain items marked with an asterisk, the Cont. Ed. Committee may be authorized to allow public comments.

People wishing to speak to the Cont. Ed. Committee are asked to fill out a comment request sheet (available at the meeting). Comments relating to a specific agenda item will be heard by the Cont. Ed. Committee as each agenda item is considered. Comment on other topics may be made during the public comment period at approximately 9:10 a.m.

Early delivery of written comments is encouraged so that the Cont. Ed. Committee members have sufficient opportunity to review materials prior to the meeting. **Directions and Parking Information:** From Interstate 5, take Exit 253 (Highway 22/Mission Street) heading west. Follow signs to the 12th Street off-ramp (about 3 miles). Take 12th Street off-ramp and merge with northbound 12th Street traffic. Follow 12th Street to Union Street (12<sup>th</sup> turns into Union). Go 3 blocks to Winter Street. Turn right on Winter Street. The Water Resources Department is in the North Mall Building on the east side of Winter Street between the Employment Building and Division of State Lands.

Street parking (90 minute) is available on the west side of the building. Metered parking is available along Summer Street and Union Streets. Hourly parking is available at Cliffs Automotive located on the corner of Court and Capitol Streets. Daily parking is available at the State yellow lot located at Marion and Summer Streets for \$6/day (machine takes bills and coins; gives change and a receipt). A Park and Ride lot is located at the State Motor Pool with buses running approximately every 15-30 minutes.
