**Directions and Parking Information:** From Interstate 5, take Exit 253 (Highway 22/Mission Street) heading west. Follow signs to the 12th Street off-ramp (about 3 miles). Take 12th Street off-ramp and merge with northbound 12th Street traffic. Follow 12th Street to Union Street (12<sup>th</sup> turns into Union). Go 3 blocks to Winter Street. Turn right on Winter Street. The Water Resources Department is in the North Mall Building on the east side of Winter Street between the Employment Building and Division of State Lands.
