Directions and Parking Information: From Interstate 5, take Exit 253 (Highway 22/Mission Street) heading west. Follow signs to the 12th Street off-ramp (about 3 miles). Take 12th Street off-ramp and merge with northbound 12th Street traffic. Follow 12th Street to Union Street (12th turns into Union). Go 3 blocks to Winter Street. Turn right on Winter Street. The Water Resources Department is in the North Mall Building on the east side of Winter Street between the Employment Building and Division of State Lands.

Street parking (2 hr) is available on the west side of the building. Metered parking is available along Summer Street and Union Streets. Hourly parking is available at Cliffs Automotive located on the corner of Court and Capitol Streets. Daily parking is available at the State yellow lot located at Marion and Summer Streets for \$6/day (machine takes bills and coins; gives change and a receipt). A Park and Ride lot is located at the State Motor Pool with buses running approximately every 15-30 minutes.
