Directions and Parking Information: From Interstate 5, take Exit 253 (Highway 22/Mission Street) heading west. Follow signs to the 12th Street off-ramp (about 3 miles). Take 12th Street off-ramp and merge with northbound 12th Street traffic. Follow 12th Street to Union Street (12th turns into Union). Go 3 blocks to Winter Street. Turn right on Winter Street. The Labor and Industries Building is on the east side of Winter Street between the State Library and the yellow lot.

Street parking (2 hr) is available on the west side of the building. Metered parking is available along Summer Street and Union Streets. Hourly parking is available at Cliffs Automotive located on the corner of Court and Capitol Streets.
