A) Cont. Ed. Committee Meeting Minutes

The amended draft minutes from the November 9, 2006, meeting were reviewed. Waldroop motioned to approve the (amended) draft minutes as is, Daugherty seconded. The vote was all in favor.

B) Other Issues

Barry Norris, Water Resources Department Technical Services Administrator addressed the Cont. Ed. Committee. Mr. Norris provided the Cont. Ed. Committee a status report of Senate Bill 88 (SB 88), which proposes to eliminate the sunset clause. Currently ORS 537.747 sunsets January 1, 2008. Mr. Norris stated SB 88 has had one hearing. The Oregon Ground Water Association (OGWA) testified and expressed concerns regarding the Department sponsoring courses, whereby competing with the OGWA. Mr. Norris added that at this time, the Department is not planning to sponsor any classes for 2007.

C) OGWA regarding safety categorizing

Nancy Sippel distributed a letter from the Washington Department of Ecology and a letter from the Idaho Ground Water Association regarding how they address safety and first aid courses, to the Cont. Ed. Committee. The Oregon Ground Water Association asked the Cont. Ed. Committee to narrow the safety/first aid/CPR category or to allow a constructor the option of using a course either in the safety/first aid/CPR category or not. The Cont. Ed. Committee discussed this in detail. Byrd motioned not to change the way the Cont. Ed. Committee is reviewing credits and directed the Department to add a box to the Sponsor Course Application form. This box on the Course Application form would allow the sponsor to check which category they prefer the course to be reviewed under. Daugherty seconded. The vote was all in favor.
