A) Cont. Ed. Committee Meeting Minutes

C) Review of Documentation

- “**IDWR Rules & Regs**” Byrd motioned to assign **zero CEC**, Daugherty seconded. The vote was all in favor.
- “**DOT-New Regulations**” Waldroop motioned to assign **one (1) CEC in**

the safety/first aid/CPR category, Byrd seconded. The vote was all in favor.

**Ron Hiddleston, #10030** submitted:

- documentation for the “**Summer Meeting**” held **August 9-10, 2004**, in **McCall, ID**, sponsored by the **Idaho Ground Water Association (IGWA)**. The Workshop was reviewed as follows:

#### B) Review of Applications

#### C) Review of Documentation

**Eric Hansen, #10067** submitted:

- documentation for presenting at the “**Water 4 Life Festival**” sponsored by the Pierce County Health Department. Byrd motioned to assign three (3) CECs, Daugherty seconded. The vote was all in favor. This was amended later in the meeting after some discussion regarding presenters obtaining CECs. Byrd amended the motion to assign one (1) CEC for the first time this was presented and 0.5 CEC the second time it was presented, during one licensing period and one (1) CEC for the first time it was presented during the second licensing period, for a total of **2.5 CECs**. Waldroop seconded. The vote was all in favor.
- documentation for a “**Basic Welding**” course taken at **Bates Technical College** in Washington. The certificate is dated June 12, 2006 for 10 hours. Byrd motioned to assign **10 CECs**, Waldroop seconded. The vote was all in favor.

- documentation for the “**2005 Annual Convention**” held **January 3, 2005**, in **Boise, Idaho**, sponsored by the **Idaho Ground Water Association (IGWA)**. Most of the courses were previously reviewed, however there were three courses that hadn’t been, they were now reviewed as follows:

- documentation for “**2006 Ground Water Summit #5095**”, taken **April 22-27, 2006** through the **National Ground Water Association in San Antonio, Texas**. Byrd motioned to assigned **six (6) CECs**, Daugherty seconded. The vote was all in favor.

D) Public Comment

At the April 27, 2006, the Cont. Ed. Committee agreed the Washington State Ground Water Association’s application form would be acceptable provided there was acceptable advertising. The WSGWA provided additional information to staff regarding their process. This was shared with the Cont. Ed. Committee at this point and found to be acceptable.

Staff shared with the Cont. Ed. Committee that a waiver of seven (7) CECs has been granted to a driller by the Director for military duty.
