## WORK SESSION: Thursday, November 29, 1:00 p.m.

- I. Climate Change Update (1:00 p.m. 3:00 p.m.) Barry Norris, State Engineer will facilitate a panel discussion of climate change projected impacts and the actions which are being taken. Panel members include: Lara Whitely Binder from the University of Washington, Climate Impact Center; Bill Drumheller, Governor's Climate Change Integration Group; Lorna Stickel, Portland Water Bureau; and, Michael Campana, Oregon State University.
- II. Oregon Water Supply and Conservation Initiative Update (3:15 p.m. 4:30 p.m.) Barry Norris, State Engineer, and Debbie Colbert, Field Services Administrator, will provide an update on the Oregon Water Supply and Conservation Initiative. In particular, draft criteria for awarding funds for regional and community-based water supply planning will be discussed with the Commission. Before convening such a session, the presiding Commission member will make a public announcement and explain necessary procedures.

**\*Public Testimony:** The Commission encourages public comment on any agenda item. However, public testimony may be limited on items marked with an asterisk (\*). The asterisk means that the item has already been the subject of a formal public hearing or contested case hearing. On certain items marked with an asterisk, the Commission may be authorized to allow public comments.

People wishing to speak to the Commission are asked to fill out a comment request sheet (available at the information table). Comments relating to a specific agenda item will be heard by the Commission as each agenda item is considered. Comments on other topics may be made during the public comment period on Friday at approximately 11:30 a.m.

Every attempt will be made to share with the Commission written comments that are delivered to the Director's Office in advance of the meeting date. Early delivery of written comments is strongly encouraged so that Commissioners have sufficient opportunity to review materials prior to the meeting. To submit written comments directly to the Commission, please bring at least ten copies to the meeting.

## **Directions to the Monarch Hotel and Conference Center**

## I-5 North

Heading north on I-5, merge onto I-205 via Exit 288; go 13.6 miles, take Exit 14, Sunnybrook Blvd/Sunnyside Rd; go 0.3 miles and turn left onto SE Sunnybrook Blvd.; go 0.1 miles and turn right onto SE 93<sup>rd</sup> Avenue. End at Monarch Hotel and Conference Center, 12566 SE 93<sup>rd</sup> Avenue.

## **I-5 South from Seattle**

Heading south on I-5, merge onto I-205S via Exit 7; go 22.8 miles, take Exit 14, Sunnyside Rd; go 0.2 miles, keep right at the fork to go onto SE Sunnyside Road.; go 0.1 miles and turn left onto SE 93<sup>rd</sup> Avenue. End at Monarch Hotel and Conference Center, 12566 SE 93<sup>rd</sup> Avenue.

## Heading West from Gorge

Heading west on I-84, merge onto I-205S via Exit 9; go 8.3 miles, take Exit 14, Sunnyside Rd; go 0.2 miles, keep right at the fork to go onto SE Sunnyside Road.; go 0.1 miles and turn left onto SE 93<sup>rd</sup> Avenue. End at Monarch Hotel and Conference Center, 12566 SE 93<sup>rd</sup> Avenue.

## From Downtown Portland

Merge onto I-84 E toward The Dalles; go 5.7 miles, merge onto I-205S; go 6.8 miles, take Exit 14, Sunnyside Rd; go 0.2 miles, keep right at the fork to go onto SE Sunnyside Road; go 0.1 miles and turn left onto SE 93<sup>rd</sup> Avenue. End at Monarch Hotel and Conference Center, 12566 SE 93<sup>rd</sup> Avenue.
