#### COMMISSION WORK SESSION: Thursday, May 4, 8:00 a.m.

#### Overview of Umatilla River Issues (8:00 am – 9:00 am)

A representative of the Confederated Tribes of the Umatilla Indian Reservation (CTUIR), elected officials, local representatives, and Department staff will provide brief overviews on historical aspects of fish recovery in the Umatilla River Basin, the Umatilla Basin Projects, the status of ground water supplies, and the Umatilla County Critical Groundwater Task Force.

## Commission Dialog with Umatilla County Critical Groundwater Task Force and Elected Officials (9:00 am – 12:00 pm)

The Commission has invited state elected officials and representatives from the Umatilla County Critical Groundwater Task Force for a conversation on key water supply issues in the Umatilla River Basin. Topics will include the economic impacts of limited water supplies, potential water supply solutions, information needs, rural water supply options, environmental considerations, and public outreach and education.

The Commission will depart from the Hermiston Conference Center at 1:30 p.m. to tour the Umatilla River Basin between Hermiston and Pendleton. The Commission will tour from approximately 1:30 p.m. to 5:30 p.m.

Phil Ward, Director, and Mike Auman, Administrator of Administrative Services Division, will provide a brief update on proposed Policy Option Packages for the 2007 – 2009 Agency Recommended Budget. *This is an informational report only*.

#### E. Commission Discussion (8:45 a.m. – 9:25 a.m.)

Time is provided for Commission discussion and follow-up from the March 7 work session and March 31 meeting. In particular, the Commission will identify a subcommittee of the Commission to work with the Department to develop potential long-term, alternative funding strategies for the Department, and possibly water development infrastructure.

# F. Reservation Request - OAR Chapter 690, Division 518 (9:25 a.m. – 9:45 a.m.) Dwight French, Water Rights and Adjudication Administrator, and Mike Reynolds, Protest Program Coordinator, will present reservation requests by the City of Lincoln City. The reservation requests are for multipurpose storage for future economic development in three waterways in the Mid Coast Basin. The question before the Commission is whether to authorize the Department to initiate of a formal rulemaking process in response to these reservation requests. The Commission will be asked to approve or deny the request to initiate rulemaking to amend OAR Chapter 690, Division 518.

# \*G. Final Proposed Rules - OAR Chapter 690, Division 217 (9:45 a.m. – 10:15 a.m.) Doug Woodcock, Ground Water Section Manager, will present a request to adopt final proposed rules under OAR Chapter 690, Division 217 (Pump Testing of Nonexempt Wells). The proposed rules would streamline pump test requirements and the administration associated with conducting pump tests and follow-up testing. *The Commission will be asked to approve the final proposed rules*.

## \*H. Final Proposed Rules - OAR Chapter 690, Divisions 200, 205, 220, 225, 240 (10:30 a.m. – 10:45 a.m.)

Barry Norris, Technical Services Administrator, will present a request to adopt final proposed rules under OAR Chapter 690, Divisions 200, 205, 220, 225 and 240 relating to Water Supply Well Constructor and Monitoring Well Constructor licensing and bonding. The proposed rules implement Senate Bill 579 (Chapter 496, 2001 Oregon Water Laws) which directed the Department to adopt a single well constructor's license by July 2006

instead of the two licenses the Department currently issues. *The Commission will be asked to adopt the final proposed rules*.

- I. Public Interest Review of Application G-16510 (10:45 a.m. 11:15 a.m.)

  Dwight French, Water Rights and Adjudication Administrator, will present ground water application G-16510 for the Commission's review and consideration of the public interest under the Umatilla Basin Program. OAR 690-507-0070(3)(d)(D). The Commission will be asked to determine if the application is consistent with the public interest.
- J. Grants Pass Irrigation District (GPID) Consent Decree (11:15 a.m. 11:30 a.m.)

  Dave Jarrett, Field Services Administrator, will present a request to join a stipulated order to amend the federal court consent decree allowing GPID to continue diverting water at Savage Rapids Dam through November 1, 2008. The Commission will be asked to join the stipulated order.
- K. Mitigation Bank Charter for Deschutes Irrigation LLC (11:30 a.m. 12:00 p.m.)

  Kyle Gorman, South Central Region Manager, will present a request for adoption of a mitigation bank charter for Deschutes Irrigation LLC pursuant to the Deschutes Mitigation Bank and Mitigation Credit rules (OAR Chapter 690, Division 521). The Commission will be asked to approve or deny the mitigation bank charter.

\*Public Testimony: The Commission encourages public comment on any agenda item. However, public testimony may be limited on items marked with an asterisk (\*). The asterisk means that the item has already been the subject of a formal public hearing or contested case hearing. On certain items marked with an asterisk, the Commission may be authorized to allow public comments.

People wishing to speak to the Commission are asked to fill out a comment request sheet (available at the information table). Comments relating to a specific agenda item will be heard by the Commission as each agenda item is considered. Comments on other topics may be made during the public comment period on Friday at approximately 12:00 p.m.

Early delivery of written comments is strongly encouraged so that Commissioners have sufficient opportunity to review materials prior to the meeting.
