This publication lists agency activities requiring public notice. It also describes public comment processes and deadlines. Types of water use requests in this week's Public Notice include:

- * Permit Application Initial Reviews, Proposed Final Orders, and Final Orders
 Applications for permits to use, store, divert or pump surface water or groundwater. Includes applications by the state Departments of Fish & Wildlife, Environmental Quality or Parks and Recreation for water to be used and kept in-channel.
- * Alternate Reservoir Applications (ORS 537.409)
 Applications for storage permits for small ponds filed under a simplified review process.
- * Expedited Secondary Applications to Use Stored Water
 Applications to use stored water exclusively, filed under a simplified review process.
- * Applications for Extensions of Time to Perfect Water Right Permits

 New applications received and proposed final orders regarding requests to extend time limits to fully develop water use projects and beneficially apply water.
- * Application for Instream Lease
 Application by water right holder to lease existing water rights to instream use.
- * Transfer Preliminary Determinations
 Requests to change point of diversion or appropriation, place of use, and character of use upon which the public may protest the application and Department's preliminary determination.
- * Transfer Applications: Permit Amendments Requests to amend permits.
- * Recommendation to Consent to Injury

 A recommendation from the agency that requested establishment of an instream water right for the Department to consent to injury of the instream water right resulting from a transfer.

Permit Application Initial Reviews and Proposed Final Orders

The following pages of this notice list permit applications that the Oregon Water Resources Department is evaluating for compliance with state water laws and regulations. Public participation and comment is encouraged. Opportunities for public involvement vary according to the stage of the permit evaluation.

Ground water permit applications in the Deschutes Basin (basin 5) may seek to provide mitigation pursuant to the Deschutes Ground Water Mitigation Rules by implementing a mitigation project or by obtaining mitigation credits made available by a completed mitigation project. Surface water and/or reservoir permit applications in the Deschutes Basin may be proposed ground water mitigation projects.

<u>Initial Review Stage (IR in the "Stage" column of the permit listing)</u>

The Department has given the applicant the results of an initial review of water use restrictions, water availability and other limits that affect the agency's decision on whether to issue a permit. The Department welcomes comments from interested persons, agencies and organizations on the proposed water use.

The comment deadline for initial reviews appearing in this public notice is 5pm, Thursday, February 28, 2013. Although we cannot respond individually to all comments, each will be considered as the agency makes its permit decision.

Proposed Final Order Stage (PFO in the "Stage" column of the permit listing)

The proposed final order is the Department's preliminary decision on the water use request. It will indicate how the comments received on the application in the first stage were considered. The PFO documents the agency's decision through specific findings. If appropriate, it includes a draft permit specifying any conditions or restrictions on the use. Persons interested in receiving a mailed copy of a PFO must pay a statutorily-required fee of \$20. (Any person paying \$20 to receive a PFO by mail will also receive a copy of the Final Order when it is issued.) PFO's may be viewed for free at the Department's Salem Office or at the district watermaster office nearest the proposed use. Those disagreeing with the Department's decision as expressed in the PFO have 45 days to file a protest.

The protest deadline for proposed final orders appearing in this public notice is 5pm, Friday, March 15, 2013.

The protest filing fee is \$300 for the applicants and \$600 for non-applicants. Detailed requirements for filing a protest will be sent with copies of the PFO. Persons who support the PFO may file a "standing" fee of \$150 to retain the ability to participate in future proceedings relating to an application. Before participation is allowed, an additional \$300 will be required at the time of the proceeding.

If a protest or comment deadline falls on a day that the office is closed then the next open business day automatically becomes the deadline date. In addition to the usual state or federal office closures, the Oregon Water Resources Department headquarters office will be closed on the following days: March 23, 2012, May 25, 2012, August 17, 2012, October 19, 2012, November 23, 2012, January 18, 2013, April 19, 2013 and May 24, 2013.



Alternate Reservoir Applications (ORS 537.409)

For alternate reservoir applications filed under ORS 537.409, the public is invited to comment within 60 days of this notice. The law provides that within 60 days after the Department provides public notice of the application, any person may submit detailed, legally obtained information in writing, requesting the Department to deny the application for a permit on the basis that the reservoir:

- (A) Would result in injury to an existing water right; or
- (B) Would pose a significant detrimental impact to existing fishery resources as determined on the basis of information submitted by the State Department of Fish and Wildlife.

Such comments must be submitted on or before April 27, 2013.

Transfer Preliminary Determinations

A Preliminary Determination provides the Department's conclusion as to whether a proposed change in place of use, point of diversion or appropriation, or character of use of an existing water right should be approved. Changes of water rights may be proposed in an application for transfer (including instream, historic POD, exchange, substitution or ground water registration modification).

The Department has issued preliminary determinations on the transfer applications listed below. In addition to this notice, the Department is complying with ORS 540.520(2) that requires publication of notice in a local newspaper for all transfers except those proposing a change in place of use only or a change in point of diversion of less than ¼ mile where there are no intervening diversion points.

Any person may protest the application and preliminary determination or may file a standing statement. Pursuant to OAR 690-380-4030(3) and OAR 690-382-0900, protests must raise all reasonably ascertainable issues and include all reasonably available arguments supporting the person's position. In addition, protests must be accompanied by a \$600 protest fee for non-applicant and \$300.00 protest fee for applicant. A Water Right Transfer Protest Form is available at http://www.oregon.gov/OWRD/PUBS/forms.shtml or by calling 503-986-0888. Protests must be received by the Department on or before March 28, 2013, or within 30 days of the last date of publication in a newspaper, whichever is later. If no protests are filed, the Department will issue a final order consistent with the preliminary determination.

T-11287 filed by Muir and McDonald Tannery, 561 SW Hayter St., Dallas, OR 97338, proposes changes in place of use and character of use under Certificate 38639. The right allows the use of 0.18 cubic foot per second (cfs) from Rickreall Creek in Sec. 32, T7S, R5W, W.M. for industrial (tannery) use in Sec. 32. The applicant proposes to create an instream use in Rickreall Creek from the point of diversion to the mouth at a maximum of 0.10 cfs. The Water Resources Department proposes to approve the transfer, based on the requirements of ORS Chapter 540, OAR 690-380-5000 and OAR 690-077-0075.

Recommendation to Consent to Injury

Pursuant to ORS 540.530(1)(c) and OAR 690-380-5050, the state agency that requested establishment of an instream water right has recommended that the Water Resources Department consent to the injury of the instream water right resulting from a proposed change in point of diversion. Copies of the transfer documents and the state agency's recommendation are available for viewing at the Salem office of the Water Resources Department.

Any person may review the recommendation and submit written comments or may submit a written request for a public meeting to review the recommendation. The right allows the use of 0.035 cubic foot per second (cfs) April-May; 0.017 cfs June-September, from the South Fork John Day River in Sec. 13, T13S, R26E, W.M. for irrigation in Sec. 13. The applicant proposes to move the POD approximately 0.4 mile upstream in Sec. 13, and to add a POD approximately 0.7 mile upstream in Sec. 24. The Department determined that the transfer would injure instream water right Certificate 59794. The Oregon Department of Fish and Wildlife (ODFW) and Department of Environmental Quality (DEQ) concluded that the transfer would result in net benefits to the resource if conditioned to require maintenance of ODFW-approved fish screens on the Miller Ditch and at the Gillespie and Harlan pump stations; and if made contingent on concurrent approval of T-10940, which proposes to move a POD downstream within a 3.4 milelong reach. The combined effects of these two transfers, and a third transfer (T-10939) proposed to be approved concurrently, would include increased fish passage and enhanced habitat due to removal of three gravel push-up dams, and better water quality and cooler water temperatures as a result of a net increase in streamflow for approximately 4.57 miles.

Notice of Receipt of Recommendations to Consent to Injury for Water Right Transfer T-11121

T-11121 filed by Paul & Dixie Schanno, 82163 Dufur Valley Rd., Dufur, OR 97012, proposes changes in point of diversion (POD) and place of use under Certificate 5678. The applicants propose to move the POD for 0.9625 cfs for irrigation of 38.5 acres approx. 8.5 miles upstream to Sec. 33, T 1 S, R 13 E, W.M. and to change the place of use within Sec. 33. The applicants propose to change the POD for 0.025 cfs for irrigation of 1 acre of land approx. 2800 feet downstream (Sec. 3, T 1 S, R 14 E, W.M.) The Department determined that the transfer would injure instream water right Certificates 59678 and 64744 due to the upstream POD movement. However, the Oregon Department of Fish and Wildlife (ODFW) and Department of Environmental Quality (DEQ) concluded that the transfer would result in net benefits to the resource if conditioned to require the following: 1) concurrent approval of application T-11120, which proposes to transfer portions of Certificates 48992, 50112 and 5678 to instream use; 2) limiting diversion of water for the 38.5 acres of the right being transferred to an upstream POD, to times when instream water right Certificates 59678 and 64744 are met; and 3) reducing the diversion rate for the portion of the 1869 water right transferred upstream (in combination with Certificate 48907 not to exceed 0.76 cfs for both rights) when the 1972 rights being transferred instream under transfer T-11120 are regulated off. The above condition #2 limitations on the times when water may be diverted for the acres transferred to the upstream POD will no longer apply if the POD is transferred back downstream to the original POD or further downstream. If the holder of the 38.5 acres of the 1869 water right leases that right or other water rights instream, ODFW and OWRD may negotiate with the water right holder to alter the restrictions under condition #2. These conditions would result in a net increase in streamflow in a proximal reach downstream from the original POD, thereby providing habitat benefits to fish, and no negative impact on stream temperature.
