Update on the 2014 Legislative Session

I. Introduction

Oregon's Legislative Assembly convened in Salem on February 3. This report provides an overview of committee membership for water-related committees and relevant legislation that was introduced.

III. Introduced Legislation

Senate Bill 1512 was introduced by the Senate Committee on Environment and Natural Resources. This bill would allow the temporary transfer or lease of determined water right claims in the Findings of Fact and Final Order of Determination in the Klamath Basin Adjudication.

House Bill 4045 removes the January 2014 sunset and reinstates the Groundwater Continuing Education Program, including the requirement that well constructors complete continuing education credits for license renewal. This bill was introduced by the House Agriculture and Natural Resources Committee.

House Bill 4044, House Bill 4064, and Senate Bill 1572 contained a number of provisions that would have placed additional requirements and restrictions on the Department in order to deny, condition, limit or restrict a new groundwater right, or to regulate a well for a senior surface water determined claim.

IV. Timelines

The short 2014 Legislative Session convened on February 3. Bills were required to pass out of first chamber committees on February 13 and second chamber committees by February 25. The Constitutional Sine Die is March 9.
