RULE SUMMARY

Within OWRD's current Division 33 Upper Columbia Rules, OAR 690-033-0120 (4) references the ODFW Fish and Wildlife Habitat Mitigation Policy rule that were subsequently modified after adoption of these rules. The proposed rule amendment to OAR 690-033-0120 (4) is to reference current ODFW Implementation of Department Habitat Mitigation Recommendations (635-415-0025). This amendment will result in OAR 690-033-0120(4) being consistent with ODFW rules. In addition rule change would remove two unnecessary hyphens [690-033-0120 (1) & (2)(a)], update the title of the Northwest Power Planning Council to its current title and update the statutory reference for fish screen design, installation, operation specifications and passage requirements [690-033-0120 (2)(c)] to achieve consistency with current ODFW revised statute references.
