RULE SUMMARY

These rules establish procedures and requirements for the funding of water resources projects having economic, environmental, and community benefits from the Water Supply Development Account. These rules are needed in order for the Oregon Water Resources Department (OWRD) to award loans and grants to qualifying water resource projects. These rules provide the process through which applicants may receive a grant or loan from OWRD for a water resource project.

The Agency requests public comment on whether other options should be considered for achieving the rule's substantive goals while reducing negative economic impact of the rule on business.
