Request for Adoption of Rules - OAR Chapter 690, Division 522, Deschutes

**Basin Water Management Rules** 

### I. Introduction

The Commission is asked to adopt amendments to OAR Chapter 690, Division 522, relating to the Deschutes Groundwater Mitigation Program. These rules operate in conjunction with the Deschutes Groundwater Mitigation Rules in OAR Chapter 690, Division 505, and the Deschutes Basin Mitigation Bank and Mitigation Credit Rules in Chapter 690, Division 521.

# II. Background

On June 4, 2010, the Commission adopted the Division 522 Deschutes Basin Water Management Rules. The rules were developed in response to feedback received from the Deschutes Work Group as part of an evaluation of the Mitigation Program required by HB 3494 (Chapter 669, 2005 Oregon Laws). The amount of new groundwater use that can be approved under the program is limited to a total of 200 cubic feet per second (cfs). Among other things, the rules changed how the Department counted new groundwater permits under the allocation cap and allowed unused permanent mitigation credits to be reassigned.

Following adoption of the rules by the Commission, the Department realized that the rules unintentionally limited when water may be incorporated back into the allocation cap and when permit mitigation credits could be reassigned upon cancellation of a permit or certificate. Specifically, the rules limit the type of cancellation to specific processes under specific statutes; however, cancellation of a permit or certificate may occur under a variety of statutes.

Currently, Division 522 specifically cites ORS 537.410 (cancellation of a permit for failure to meet construction conditions), ORS 540.621 (voluntary cancellation of a certificate), and ORS 540.610 (forfeiture of a certificated water right). This prevents reassignment of permanent mitigation credits and inclusion of water back into the allocation cap if cancellation occurs under another statute or process.

This issue was highlighted as part of the 2012 annual evaluation and 5 year evaluation of the Mitigation Program presented to the Commission in March 2014, and again in the 2013 annual report presented to the Commission in March 2015. During the 2014 meeting, the Commission directed staff to initiate rulemaking to clarify how the Department incorporates water back into the allocation cap and reassigns permanent mitigation credits based on cancellation of a permit.

# III. Rulemaking Process

Prior to convening a Rules Advisory Committee (RAC), Department staff developed a draft set of rules. On January 5, 2015, the Department convened a RAC to assist the Department in reviewing the proposed changes to Division 522. A list of RAC members is provided in Attachment 2.

RAC members were supportive of the proposed rule changes. During RAC discussions an additional provision was suggested by one RAC member, but was ultimately not incorporated into the rules. The recommendation was to allow those with municipal or quasi-municipal permits to reassign permanent mitigation credits to other municipal or quasi-municipal permit holders with incremental development plans.

The Department held a public hearing in Bend on March 30, 2015. Testimony was provided by two individuals (Peter Goodmonson and John Short) in support of the proposed changes. The public comment period closed on March 31, 2015. One written comment in favor of the proposed rules was received from Peter and Sari Goodmonson and is provided in Attachment 3.

#### IV. Discussion

The proposed amendments to the rules are intended to provide additional flexibility and clarity to the Deschutes Basin Water Management Rules when adding water back into the 200 cfs allocation cap and/or reassigning permanent mitigation credits when a groundwater permit or certificate is cancelled. Under the existing rules, water may only be added back to the allocation cap or credits may only be reassigned if cancellation occurs under specific statutes referenced in the rules. The proposed rules would eliminate the reference to specific cancellation statutes, thereby allowing all types of cancellation processes to qualify under the program. The final proposed rules are provided in Attachment 1.

Seven permits totaling 0.549 cfs have been cancelled by the Department. Three of these permits were cancelled voluntarily and four were cancelled under ORS 537.260. The 0.549 cfs associated with these rights cannot be incorporated back into the allocation cap as the permits were not cancelled under ORS 537.410. In addition, the current rules unintentionally prevent 9.0 permanent credits associated with one of the cancelled permits to be reassigned to another credit holder or groundwater user.

The proposed amendments to the rules will allow the Department to incorporate the 0.549 cfs back into the allocation cap and allow the former permittee (Peter Goodmonson) with 9.0 permanent mitigation credits to reassign those to another mitigation credit holder or groundwater user.

# V. Summary

The final amended rules in Attachment 1 (Deschutes Basin Water Management, OAR Chapter 690, Division 522) provide greater flexibility by allowing the Department to incorporate water back into the allocation cap when a permit or certificate is cancelled regardless of the cancellation process. In addition, when a permit or certificate is cancelled, the former water right holder will be able to reassign any permanent credits to another credit holder or groundwater user.

#### VI. Alternatives

The Commission may consider the following alternative actions:

- 1. Adopt the final proposed rules in Attachment 1.
- 2. Adopt modified final proposed rules.
- 3. Not adopt the proposed rules and request that the Department further evaluate the issues.

#### VII. Recommendation

The Director recommends that the Commission adopt the final proposed rules in Attachment 1.
