



The Water Resources Development Program seeks to help individuals and communities address instream and out-of-stream needs now and into the future, including water quantity, water quality and ecosystem needs.



Place-Based Planning

Purpose: Understand the water resources and develop integrated solutions to address a basin's water needs.





Pilot Areas

Pilot Phase: 2015-2019 \$750,000 to pilot Place-Based Planning

Reserve Fund Request

Request to use up to \$93,000 to:



Provide additional support to the partially funded pilots as needs are identified

Engage experts to assist all four pilot areas





Assist in funding a workshop in spring 2017

- Attract and leverage additional funding





Engage Experts as Pilot Resources



Develop and deliver targeted training to each pilot



Proactively identify and manage potential challenges



Develop strategies for documenting and communicating lessons learned

Bring pilot planning groups and key partners together to share and capture lessons learned from Planning Step 1 and build momentum for Planning Steps 2-3.



Justification/Reasoning

Why Now?

- Allows timely decisions and use during Steps 1 & 2
- Capitalize on potential match
- Enables Department to be adaptive and responsive

Path Forward

- Continue to engage pilots
- Expend funds on the items listed
- Report on expenditures at future meetings



Alternatives
