- * Applications for Extensions of Time to Perfect Water Right Permits

 New applications received and proposed final orders regarding requests to extend time limits to fully develop water use projects and beneficially apply water.



Initial Review and Proposed Final Orders

The following pages of this notice list permit applications that the Department is evaluating for compliance with state water law. Public participation and comment is encouraged. Opportunities for public involvement vary according to the stage of the permit evaluation. Ground water permit applications in the Deschutes Basin (Basin 5) may seek to provide mitigation pursuant to the Deschutes Ground Water Mitigation Rules.

Initial Review Stage (IR)

The Department has given the applicant an initial review of water-use restrictions, water availability and other limitations that affect the agency's decision on whether to issue a permit. The Department welcomes comments from interested persons, agencies and organizations on the proposed water use. **The comment deadline for initial reviews appearing in this public notice is 5pm, Thursday, February 02, 2017.** Although we cannot respond individually to all comments, each will be considered as the agency makes its decision regarding proposed allocations.

Proposed Final Order Stage (PFO)

The proposed final order is the Department's penultimate decision on the water use request. The PFO documents the agency's decision through specific findings, including review of comments received. If appropriate, it includes a draft permit specifying any conditions or restrictions on the use. Persons interested in receiving a mailed copy of a PFO must pay a statutorily-required fee of \$25. (Any person paying \$25 to receive a PFO by mail will also receive a copy of the Final Order when it is issued.) PFO's may be viewed free of charge online at: http://apps.wrd.state.or.us/apps/wr/wrinfo/. Those disagreeing with the Department's decision as expressed in the PFO have 45 days to file a protest.

The protest deadline for proposed final orders appearing in this public notice is 5pm, Friday, February 17, 2017.

The protest filing fee is \$350 for the applicants and \$700 for non-applicants. Detailed requirements for filing a protest are included in the PFO. Persons who support the PFO may file a "standing" fee of \$200 to retain the ability to participate in future proceedings relating to an application. Before participation in a hearing is allowed, an additional \$500 will be required to request to participate as a party or limited party.

If a protest or comment deadline falls on a day that the office is closed, then the next open business day automatically becomes the deadline date.

Applications for Allocation Of Conserved Water

The following applications for allocation of conserved water have been received pursuant to ORS 537.455 to 537.500 and OAR Chapter 690, Division 18. In reviewing the applications, the Department will consider whether the diversion for the uses allowed under the original water right will be reduced by the conservation project, whether existing water rights will be protected from injury, and whether the project is in compliance with local comprehensive land use plans.

Notice of Application for Allocation of Conserved Water CW-93

CW-93 filed by East Fork Irrigation District, PO Box 62, Odell, OR 97044, proposes to pipe approximately 10,000 feet of the open and unlined Highline Canal with new PVC gasketed pipe, eliminating seepage losses, overflow and/or operational spills. The project on the East Fork Hood River is expected to conserve approximately 0.7 cubic feet per second (CFS) and 166.6 acre-feet (AF) under Certificate 92000 with a priority date of Nov. 25, 1895.

The applicants propose 75% (0.525 cfs) of the conserved water be protected instream in the East Fork Hood River. The increased flow will benefit East Fork Hood River populations of threatened and endangered species of Chinook and Coho salmon and mid-Columbia River steelhead trout. The East Fork Hood River is also listed on Oregon's DEQ's 303(d) list for impaired water quality. The project appears to be consistent with the requirements under ORS 537.470. Any interested person may submit written comments for the applications. Comments must be received within 20 days of this publication, 1/31/2017. Notice of Application for Allocation of Conserved Water CW-95 and Change in Point of Diversion

CW-95 filed by Woody and Megan Wolfe, 81544 Hwy 82, Wallowa, OR 97885, proposes to convert 871.5 acres from flood irrigation to high efficiency center pivot irrigation. The project on the Lostine (aka South Fork Wallowa) and the Wallowa Rivers is expected to conserve at total of approximately 7.33 cubic feet per second (CFS) and 1234 acre-feet (AF) as follows:

The remaining 27% of Cert. 53047 will be retained by the Applicants for future out-of-stream use.

The Applicants propose to change the point of diversion for the 118.8 acres involved in this application under Certificate 81644 by moving it downstream approx. 5 miles from the Westside Ditch located in NWSE of Sec. 27, T1S, R43E, W.M. to the Foster Ditch located in NENW of Sec. 4, T1N, R43E, E.M.

The project appears to be consistent with the requirements under ORS 537.470. Any interested person may submit written comments for the applications. Comments must be received within 20 days of the last day of publication, 1/31/2017. Comments should be sent to the attention of the ACW Program, Water Resources Department, 725 Summer Street NE, Suite A, Salem, OR 97301.

Proposed Final Orders Regarding Applications for Extensions of Time for Water Right Permits

Procedures for permit holders to apply for extensions and for the Department to evaluate and determine whether or not to approve extensions of time are contained in OAR 690-320-0010 for extensions filed before July 1, 2001, and in OAR 690-315-0010 for extensions filed on or after July 1, 2001.

Proposed Final Orders (PFO's) are the Department's preliminary decision on extension requests. They document the agency's decision through specific findings. Persons interested in receiving a mailed copy of a PFO must pay a statutorily-required fee of \$25. (Any person paying to receive a PFO by mail will also receive a copy of the Final Order when it is issued). PFO's may be viewed for free at the Department's Salem Office or at the appropriate watermaster district office.
