


# Background

**Public Ownership:** Mostly U.S. **Forest Service** (green) Oregon Dept. of State Lands (blue)



#### **Characteristics of the Watershed**


- 13 miles of Federal Wild and Scenic River
- Kalmiopsis Wilderness
- South Kalmiopsis and Packsaddle Inventoried Roadless Areas
- Low use and limited access
- Fisheries and Plants
  - Northwest Forest Plan key watershed
  - Critical habitat for threatened Coho salmon



# **Federal Withdrawal**

January 2017 public land order, 20-year withdrawal:

> does not prevent development of existing valid mining claims



#### **Other Agencies' Actions**

 DEQ rulemaking to consider designating the Smith River Watershed as an Outstanding Resource Water
outstanding state resource due to extraordinary water quality or ecological values
or to maintain critical habitat areas

Environmental Quality Commission likely to consider proposed rule in June 2017

## **Petition for Withdrawal**

Received August 2015 - Proposed to withdraw all surface and groundwater from appropriation except for instream, and including exempt uses

November 2015 - Commission directed staff to undertake a basin program amendment to classify the waters for instream uses

Issuing withdrawal order legally problematic

### **Overview of Classifications**

- Classification of sources of water has the effect of restricting the new uses allowed for new water rights to those that are specified by the classification
- No other uses are allowed, except:
  - uses that do not require a water right
  - alternative reservoirs
  - other uses as allowed by law or approved by the Commission

### Considerations

ORS 536.220 provides for an "integrated state water resources policy"

actions to facilitate "the maximum beneficial use and control

consideration of the "multiple aspects" of water use

ORS 536.310 - outlines purposes and policies to be considered

12 components - summarized in the staff report

#### **Review of Proposed Rules**

#### Current classified uses:

Domestic, livestock, municipal, industrial, fire control, irrigation, agricultural use, mining, power development, recreation, wildlife, and fish life uses

#### Proposed rules classify:

surface waters for human consumption, livestock, and instream public uses (including pollution abatement, fish life, wildlife and recreation)


groundwater for exempt uses outlined in ORS 537.545

## **Rulemaking Process**

- RAC was held June 30, 2016 in Brookings, OR
- Notice of rulemaking was published in the September 2016 Oregon Bulletin
- September 28, 2016 request to extend the public comment deadline by 30 days
- Public Hearing was held in Brookings on September 29, 2016
- Public comment period closed on October 28, 2016
- Received over 2,000 comments
