690-01-000 Prior to the adoption, amendment, or repeal of any permanent rule by the Water Resources Commission, the Water Resources Department shall give notice of the proposed adoption, amendment or repeal:

- (1) In the Secretary of State's Bulletin referred to in ORS 183.360 at least [fifteen (15)] twenty-one (21) days prior to the effective date.
- (2) By mailing a copy of the notice and a copy of the rule or an explanation of how the person or organization may acquire a copy of the rule to persons and organizations on the Water Resources Department's mailing list established pursuant to OR 183.335(7) at least [fifteen (15)] twenty-eight (28) days prior to the effective date.
- (3) By mailing a copy of the notice to the following persons, organizations or publications:
  - (a) Sta[g]te agency members of the Strategic Water Management Group (ORS 537.100);
  - (b) [United Press International and] Associated Press;
  - (c) Persons and organizations filing a written request for such notice with the Department who are not on the mailing list referred to in subsection (2) of this rule; and
  - (d) Cities, counties, and local planning agencies likely to be directly affected by the proposed rule.

## RULEMAKING; ATTORNEY GENERAL'S MÓDEL RULES

**Notice** 

690-01-000 Prior to the adoption, amendment, or repeal of any rule by the Water Resources Commission the Water Resources Department shall give notice of the proposed adoption, amendment, or repeal:

(1) In the Secretary of State's Bulletin referred to in ORS 183.360 at least 21 days prior to the

effective date.

(2) By mailing a copy of the notice and a copy of the rule or an explanation of how the person or organization may acquire a copy of the rule to persons and organizations on the Water Resources Department's mailing list established pursuant to ORS 183.335(7) at least 28 days prior to the effective date.

(3) By mailing a copy of the notice to the

following persons, organizations, or publications:
(a) State agency members of the Strategic Water Management Group (ORS 536.100);

(b) Associated Press; (c) Persons and organizations filing a written request for such notice with the Department;

(d) Cities, counties, and local planning agencies likely to be directly affected by the proposed rule.
