### RULE SUMMARY

HB 3369, enacted into law by the Oregon Legislature in 2009, directs the Oregon Water Resources Commission to adopt rules establishing standards for borrowers obtaining loans issued from the Water Development Fund. In addition, HB 3369 establishes a separate and distinct process for certain applicants seeking a loan from the Water Development Fund. These applicants include qualified water developers that are not a municipality or a provider of water for municipal purposes and that are applying for a loan to enable the construction of a water development project in the Columbia River Basin. The adopted rules provide procedures and establish standards for administration of a Water Development Loan Program for applicants that are not a municipality or a provider of water for municipal purposes and that are applying for a loan to enable the construction of a water development project in the Columbia River Basin in accordance with HB 3369 (Chapter 907, Oregon Laws 2009).
